- CLOSED MEETING: Ms. Friedenberg moved that the Special Conference Committee of the Board of Nursing convene a closed meeting pursuant to Section 2.2-3711(A)(27) of the *Code of Virginia* at 9:11 A.M. for the purpose of deliberation to reach a decision in the matter of Ms. Canady. Ms. Friedenberg moved to offer a Consent Order to Mary McCloud Reprimanding her and Indefinitely Suspending her professional nursing

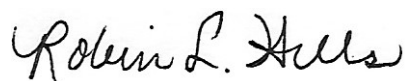
license in lieu of a Formal Hearing. The motion was seconded and carried unanimously.
