#### Lake Martin Update

Mr. Gavan presented an overview of progress on Lake Martin since the September meeting and provided a progress letter from Fairfax County (Copy attached as Attachment #1) He noted that there has been some progress toward the trial. The county is working on the survey but still encounters some problems with access to the land.

In further developments, the county has revised plans and received acceptance from the Governor's Run subdivision to retrofit two storm water management ponds.

MOTION: Mr. Bond moved that the Virginia Soil and Water Conservation

Board receive the written progress report from Fairfax County outlining current and proposed actions to bring resolution to the Lake Martin watershed erosion and sediment control problems under the enforcement authority of the Fairfax County Erosion and

Sediment Control Program, and that the Board note the efforts by Fairfax County to bring resolution to this issue and requests the County to continue it's efforts to expedite resolution to facilitate remediation of the Lake Martin watershed.

The Board further directs Fairfax County to continue to provide updates to the Board relative to the progress in completing the final design and construction specification documents, the proposed plans and schedule for commencement of restoration actions and the actual progress in restoration. The County should insure that affected homeowners are provided input into the process of determining the final remediation plans. These updates shall continue until restoration actions have been completed.

### Chesterfield County Petition to Create a New Soil and Water Conservation District

Mr. Browning called members attention to letters provided in their packet (Copy attached as Attachment #2).

He noted that there were several letters regarding a request from Chesterfield County to form a new Soil and Water Conservation District.

Mr. Browning noted that after consultation with Fred Fisher of the Office of the Attorney General that Mr. Fisher had declared that the petition complies with the requirements of Section 10.1-507 and 10.1-508 of the *Code of Virginia*.

Mr. Browning called to member's attention letters provided in their packets addressing the concerns of some SWCDs with the creation of new Districts. (Copy attached as Attachment #3)

# Agriculture Stewardship Act Case #093 – Robert C. & Martha C. Dantzler Appeal

Mr. Browning referenced materials previously mailed to members regarding the Dantzler appeal. He noted that the information was mailed with respect to a possible hearing to be held regarding the appeal.

Mr. Browning explained that approximately two and one half years ago, Robert C. and Martha Dantzler were notified that they were in violation of a provision of the Agriculture Stewardship Act.

Mr. Browning explained that as a result of a public hearing as well as correspondence with the Dantzlers that the substance in question was re-sampled and determined to be compost.

As a result the Commissioner sent a letter indicating a change in the corrective order. This change was accepted by the Dantzlers, which provided a satisfactory response to their appeal with the Virginia Soil and Water Conservation Board.

### **Impoundment Safety Technical Advisory Committee Report**

Mr. Moyer reported that the Impoundment Safety Technical Advisory Committee met on November 15 in Charlottesville. He said the committee spent a good deal of time discussing visions and clarifications to impoundment structure regulations.

Mr. Phillippe noted that the committee is looking at revisions that need to occur to insure compliance with the changes in the law.

Mr. Horn thanked Mr. Moyer for the report. He thanked Dr. Gilliam for serving as chair of the Technical Advisory Committee.

Mr. Horn noted that with the appointment of Mr. Maitland, Dr. Gilliam would be leaving the Board. He thanked Dr. Gilliam for his commitment to the Board and to soil and water conservation in the Commonwealth.

Mr. Horn noted that appointment of two board members to serve the Technical Advisory Committee should be on the agenda for the January meeting.

Mr. Phillippe noted that the Technical Advisory Committee has tentatively scheduled their next meeting for April.

MOTION Dr. Gilliam moved that the report of the Impoundment Safety

Technical Advisory Committee be approved as submitted.

SECOND Mr. Dunford.

DISCUSSION None.

APPROVED Unanimously.

## **Dam Safety Regulations**

Mr. App reference materials provided to members in their packets entitled Final Regulatory Action Motion To Promulgate Amendments to Impounding Structure Regulations: 4 VAC 50-20-30, 4 VAC 50-20-50, 4 VAC 50-20-70, 4 VAC 50-20-120, 4 VAC 50-20- 220, and 4 VAC 50-20-320.

He noted that the current regulation under review is exempt from the Administrative Process Act since it is being changed to comply with changes in the law. Still amendments must be posted with the Virginia Registrar of Regulations thirty days prior to enactment.

In the packet there are two sections of definitions. The first set will go into effect thirty days after publication. The second set will be effective July 1, 2002.

**MOTION** 

Mr. Bond moved that the Virginia Soil and Water Conservation Board authorize the Director of the Department of Conservation and Recreation and the Departmental Regulatory Coordinator to publish the final regulatory amendments necessary to bring the Virginia Impoundment Regulations, including the attendant forms, into conformance with changes made to the Code of Virginia, the Department of Conservation and Recreation organizational changes, and the federal organizational changes since the last regulatory amendment, and that the Board further request that the Director and the Regulatory Coordinator report to the Board on these actions at the January Board meeting.

**DISCUSSION** 

Mr. App noted the following:

Assistant Attorney General Rick R. Linker has advised that all the proposed actions be prepared for one combined regulatory action. Therefore, for the entire package the effective date shall be 30 days following publication in the <u>Virginia Register of Regulations</u> with the exception of the second version of 4 VAC 50-2-30 marked as effective July 1, 2002 due to the effective date of Chapter 92 of the 2001 Virginia Acts of Assembly. The second version of 4 VAC 50-20-20 shall be published with the other amendments, but shall be effective on July 1, 2002 as indicated. At that time the first amended version of 4 VAC 50-20-20 shall be replaced and repealed.

This Final Regulatory Action authorization is for those amendments exempt from the Virginia Administrative Process Act due to lack of agency discretion, which are subject only to the Virginia Register Act, and as approved by Assistant Attorney General Rick R. Linker in his letter of December 7, 2001. This Final Regulatory Action approval is subject further to the formal decision of the Virginia Registrar of Regulations regarding the federal organizational name change of the Soil Conservation Service to the Natural Resource Conservation Service. Informal discussion with Ms. Jane D. Chaffin indicates her approval of this action when formally submitted to her. This authorization extends to the coordination necessary to gain any approvals necessary from the Attorney General, and the Virginia Registrar of Regulations and to publish the same in the Virginia Register of Regulations and electronically on the Virginia Town Hall.

Mr. Browning noted that members were provided results in the mail and in their packets (Copy attached as Attachment #4)

He noted that the Department no longer receives a list of the votes cast and that it is the responsibility of the elected individual to take the appropriate oath of office and file the forms according to the instructions provided.

### **Agency Reports**

#### Natural Resources Conservation Service

Ms. Doetzer gave the report for NRCS. (Copy attached as Attachment #5).

Mr. Dunford said that he would like to publicly thank Ms. Doetzer or providing the Henricopolis District the opportunity to tour the NRCS offices in Richmond.

#### Virginia Department of Forestry

Not represented.

## Virginia Cooperative Extension Service

Dr. Gardner said that he would like to echo the information from Ms. Doetzer regarding the need for funding the solar lab at Virginia Tech.

He noted that Virginia Tech is dealing with budgetary issues such as employee salaries, teacher salaries and more and currently has a rather large budget deficit.

He noted that, as members know, the state has had some very dry conditions. The water shortage appears to be a statewide issue.

He noted that the Extension Services is also concerned about biosecurity.

### Virginia Department of Agriculture and Consumer Service

Mr. Seward echoed Dr. Gardner's comments concerning the lack of rainfall. He noted that October and November of 2001 were some of the driest months on record.

VDACS is following the progress of the farm bill in the U.S. Congress. He noted that they hope the bill will allow for some flexibility with how farmers deal with conservation needs.

The Ag Stewardwarship Program is now in it's fifth year. There have been 174 official complaints, but the department has received numerous requests that don't meet the requirements.

#### Department of Conservation and Recreation

Mr. App noted that DCR has looked at the possibility of additional measure to deal with dam safety in the event of a terrorist attack. Delegate Sherwood has asked DCR to review a proposal.

Mr. Brickley and Jack Frye are attending the Bolling Commission meeting. The Commission is considering a bond proposal that would appropriate about eleven million dollars for district dams and repairs.

The Governor has reported necessary budget reductions and indicated that agencies should prepare for a 2% reduction in their budgets.

Mr. Dunford asked if DCR was considering staff reductions at this time.

Mr. App noted that he couldn't say at this time.

#### Other Business

Mr. Hall noted that the Board had previously been scheduled to come to Buchanan County and meet at The Breaks Interstate Park. He said he would like to reschedule that meeting.

Mr. App said that the problem was the additional expense associated with staff travel to meetings. He noted that projections for next year's travel budget were uncertain.

Dr. Gilliam expressed his gratitude and appreciation for the opportunity to work with the Board for the last eight years. He noted that he will still be representing his district. He noted that a positive result of his leaving the Board was the opportunity for Mr. Maitland

to fill the vacant position. He congratulated Mr. Maitland and wished the Board success in the future.
