### **Study Topics**

- · Existing forensic nursing (FN) programs in Virginia
- Regions with no FN programs or nurses and closest location to receive services
- · Current funding sources for existing FN programs
- · Creating new programs: cost and potential funding sources
- · Cost of evidence collecting and court testifying
- Potential funding sources for testimony costs
- Current FN workforce and ways to increase availability of FN certifications to nurses
- Insurance reimbursement for FN services
- Best practices in other state FN programs, including telehealth

#### **Statistics**

- 96 to 155 trained forensic nurses in Virginia
  - 93,902 Registered Nurses total
- Out of 122 licensed hospitals in Virginia:
  - 16 hospitals provide sexual assault exams
    - 1 only provides pediatric forensic nursing
  - 1 non-hospital based mobile forensic nurse service
  - 11 of the 16 forensic medical exam hospitals have trauma care designations
    - 8 of the 19 Virginia trauma care hospitals do not offer forensic examinations

## **EVIDENCE PRESERVATION BY TRANSFER HOSPITALS**

## Excerpt from Draft Model Adult Transfer Plan

The transfer hospital must maintain a chain of custody in the handling of the adult survivor and any clothing and shall handle it as minimally as possible. The transfer hospital will not attempt to obtain any specimens for evidentiary purposes (e.g., blood, saliva, hair samples, etc.) . If the adult survivor needs to urinate, the transfer hospital should then collect the urine/diaper and maintain chain of custody of the item during transfer. If removal of any clothing is necessary to render emergency services, removal should be attempted without cutting, tearing, or shaking garments. All loose or removed articles of clothing or other possessions of the adult survivor shall be left to dry if possible, placed in separate paper bags, and then placed in one larger paper bag. The bag shall be sealed and labeled with the adult survivor's name, the names of the health care personnel in attendance, the type and description of contents, the date, and the time collected. If the bag is not collected by law enforcement at the transfer hospital prior to transfer, the bag shall be transported with the adult survivor to the treatment hospital.


