### Meeting Minutes

Attendance: 26 in person, 51 online

**10:00am –** Chad Aldridge called the meeting to order and presented the new 2023 VSSTF Voting Members.

**10:30am** – Alan Stillman (Kwikpoint) and Amy Swierczewski (Medical Society of VA) presented the pilot program of Stroke Smart Medical Practices in partnership with Bon Secours Health System. Recommended criteria for the Stroke Smart Medical Practices model was presented to the VSSTF Voting Members for feedback.

Two challenges were brought up regarding feasibility of the Stroke Smart initiative within the medical practice setting: 1). Inundated with trainings already, 2). High turnover in medical practices.

The VSSTF Voting Members voted on the proposed criteria. David Long motioned to approve, Dr. Doss seconded. All were in favor of the Stroke Smart Medical Practices criteria as presented.

Public Comment: Bon Secours practices received this program well. Recommend identifying measures to determine effectiveness, such as # of materials distributed, referrals to 911, QR codes to track exposure.
