After consideration, Mr. Motley moved to accept the violation of Count 1 as recommended in the Summary of the Informal Fact-Finding Conference, which cites a violation of 18 VAC 25-21-110.1.a of the Board's 2002 regulations. Ms. Pence seconded the motion which was unanimously approved by members: Motley, Pence, and Perkinson. Mr. Motley moved to accept the violation of Count 2 as recommended in the Summary of the Informal Fact-Finding Conference, which cites a violation of 18 VAC 25-21-110.2 of the Board's 2002 regulations. Ms. Pence seconded the motion which was unanimously approved by members: Motley, Pence, and Perkinson. Mr. Motley moved to accept the violation of Count 3 as recommended in the Summary of the Informal Fact-Finding Conference, which cites a violation of 18 VAC 25-21-110.6 of the Board's 2002 regulations. Ms. Pence seconded the motion which was unanimously approved by members: Motley, Pence, and Perkinson. Mr. Motley moved to accept the violation of Count 4 as recommended in the Summary of the Informal Fact-Finding Conference, which cites a violation of 18 VAC 25-21-110.7 of the Board's 2002 regulations. After Ms. Perkins indicated that there have been no prior disciplinary actions against Mr. Strosnider, Mr. Motley moved to amend the recommended sanctions contained in the Summary of the Informal Fact-Finding Conference and impose a monetary penalty of \$200 for each of the violations in Counts 1, 2, 3, and 4, and a monetary penalty of \$500 for the violation in Count 5, for a total monetary penalty of \$1300. Ms. Pence seconded the motion which was unanimously approved by members: Motley, Pence, and Perkinson. As the presiding Board member at the Informal Fact-Finding Conference, Mr. Updike was not present during the discussion or votes.

involving Randy's Auction Gallery, Mr. Motley moved to accept the Summary of the Informal Fact-Finding Conference and impose the following sanctions: \$650 monetary penalty for Count 1; \$650 monetary penalty for Count 2; \$650 monetary penalty for Count 3; \$650 monetary penalty for Count 4; \$650 monetary penalty for Count 5; \$500 monetary penalty for Count 6; \$250 monetary penalty for Count 7; \$250 monetary penalty for Count 8; \$250 monetary penalty for Count 9; \$350 monetary penalty for Count 10; \$500 monetary penalty and revocation of Randy's Auction Gallery but stay the imposition of revocation contingent on the following terms being met: 1) Randy's Auction Gallery is to commit no violation of the Board's regulations or any auction regulation in any state where Randy's Auction Gallery is licensed for the next five years; and 2) Randy's Auction Gallery's contract is to be revised so that it complies with the Board's regulations and a copy is to be submitted to the Board within 30 days of the entry of the Order, for Count 11; \$500 monetary penalty and revocation to be stayed pursuant to the terms of Count 11 for Count 12; \$500 monetary penalty and revocation to be stayed pursuant to the terms of Count 11 for Count 13; and \$2,500 monetary penalty and revocation to be stayed pursuant to the terms of Count 11 for Count 14, for total monetary penalties of \$8,850. Ms. Pence seconded the motion which was unanimously approved by members: Motley, Pence, and Perkinson. The suspension shall be stayed if, during the two-year period of suspension, First Guarantee Credit Corp. does not violate any of the regulations of the Virginia Auctioneers Board, or any other local, state or national auctioneer regulatory body. If a violation occurs, First Guarantee Credit Corp.'s Virginia license may be fined, suspended, or revoked, subsequent to Board review. Ms. Pence seconded the motion which was unanimously approved by members: Motley, Pence, and Perkinson. As the presiding Board member at the Informal Fact-Finding Conference, Mr. Updike was not present during the discussion or votes.
