Finding a quorum of the Board present, Mr. Motley, Chair, called the meeting to order at 10:04 a.m.

Call to Order

Mr. Courtney noted that the Department has added many new positions to the Compliance and Investigations Division. Mr. Christner introduced the new employees and stated they are a welcome addition to the Department.

Introduction of Staff

Mr. Motley noted that he appreciates all the work that Mr. Updike does for the Auctioneers Board; he does a great job for the Board and the profession.

Recognition of Board Designee

Mr. Bryant moved to approve the agenda. Ms. Wang seconded the motion which was unanimously approved by members: Bryant, Motley, Pence, and Wang.

Approval of Agenda

Ms. Pence seconded the motion which was unanimously approved by members: Bryant, Motley, Pence, and Wang.

Public Comment Period – There were no comments made to the Board.

Public Comment

Mr. Courtney informed the Board of Mr. Garten's recent resignation from the Board. Mr. DeBoer stated that new appointments are in limbo at this time but hoped that a new member would be appointed before the next Board meeting in July.

Board Member Resignation

Mr. Motley turned over the position of Chair to Ms. Pence and recused himself from the meeting.

Transfer of Chair

Regarding File Number 2007-01975, Carwile Auctions, the Board members reviewed the Consent Order as seen and agreed to by Carwile Auctions. Ms. Wang moved to accept the Consent Order which cites a violation of 18 VAC 25-21-110 of the Board's regulations. For this violation, Carwile Auctions agrees to the following sanctions: \$1,000.00 for the violation contained in Count 1, as well as \$150.00 in Board costs for a total monetary penalty of \$1,150.00. Mr. Bryant seconded the motion which was unanimously approved by members: Bryant, Pence, and Wang.

As the reviewing Board member Mr. Motley was not present during the discussion or vote.

Mr. Motley returned to the meeting and resumed the position of Chair.

Ms. Wang seconded the motion which was unanimously approved by members: Bryant, Motley, Pence, and Wang.

Ms. Perkins informed the Board that Calvin Zedd has had prior violations. Mr. Motley moved to accept and amend the recommended sanctions as contained in the Summary of the Informal Fact-Finding

Conference amending the sanction contained in Count 2 from \$500.00 to \$2,000.00 due to the severity of the violation as well as the previous violations to the Board's regulations: \$200.00 for the violation contained in Count 1; \$2,000.00, as amended, and license revocation for the violation contained in Count 2; and \$2,450.00 and license revocation for the violation contained in Count 3; for a total monetary penalty of \$4,650.00. Ms. Pence seconded the motion which was unanimously approved by members: Bryant, Motley, Pence, and Wang.

Regarding File Number 2007-03360, Zedd Auctioneers, LTD, the Board members reviewed the record of the Informal Fact-Finding Conference, which consisted of the investigative file, transcripts and exhibits, and Summary of the Informal Fact-Finding Conference. Ms. Pence moved to accept the Summary of the Informal Fact-Finding Conference as to the facts, which cites the following violations of the Board's regulations: 18 VAC 25-21-110.1.a (Count 1); 18 VAC 25-21-150.C (Count 2); and 18 VAC 25-21-180.A.6 (Count 3). Ms. Wang seconded the motion which was unanimously approved by members: Bryant, Motley, Pence, and Wang.

File Number 2007-03360, Zedd Auctioneers, LTD

Ms. Perkins informed the Board that Zedd Auctioneers, LTD, has had prior violations. Mr. Motley moved to accept and amend the recommended sanctions as contained in the Summary of the Informal Fact-Finding Conference amending the sanction contained in Count 2 from \$500.00 to \$2,000.00 due to the severity of the violation as well as the previous violations to the Board's regulations: \$200.00 for the violation contained in Count 1; \$2.000.00 as amended, and license revocation for the violation contained in Count 2; and \$2,450.00 and license revocation for the violation contained in Count 3; for a total monetary penalty of \$4,650.00. Ms. Pence seconded the motion which was unanimously approved by members: Bryant, Motley, Pence, and Wang.

Mr. Courtney provided the Board members with information regarding the eBay Trading Assistant Program. Mr. Courtney noted that the agreement states that a Trading Assistant may not use the terms "Auction" or "Auctioneer."
