The Department received Mr. Zedd's letter surrender ing both licenses on April 14th; however, the letter was not seen by Board staff until after the April 17th Board meeting. Therefore, pursuant to the agreement between Mr. Zedd and Board counsel, Ms. Wang moved to vacate the Orders resulting from File Numbers 2007-02784 and 2007-03360. Mr. Bryant seconded the motion which was unanimously approved by members: Bryant, Motley, and Wang.

Reconsideration of Board Orders 2007-02784, Calvin Zedd; and 2007-03360, Zedd Auctioneers, LTD.

The Board members reviewed a letter from Frank MaGann at VCPM Auctions, LLC, requesting a Board determination of regulation 18 VAC 25-21-150. After review and discussion, the Board members requested that staff prepare a draft to amend Board regulation 18 VAC 25-21-150 for a fast track regulation change, which the Board will review at their next Board meeting. The Board requested staff to prepare correspondence to Mr. MaGann notifying him of the Board's action.
