CALL TO ORDER

Ms. Rogers called the meeting to order at 10:07 a.m.

Welcome New Members

Ms. Rogers welcomed committee members, VBOA and VSCPA staff. She thanked the committee members for their service.

Introductions of PROC members

Ms. Rogers, committee members, VBOA staff and Mr. Windschitl introduced themselves and provided a brief history of PROC.

PEER REVIEW REQUIREMENTS

Peer Review Program Manual

Mr. Mahbod led the discussion regarding the Peer Review Program Manual. Ms. Rogers and Mr. Mahbod noted the purpose of the PROC is to provide reasonable assurance that participating entities are complying with the administrative procedures acceptable to the Board. Mr. Mahbod provided an overview of the peer review process.

Report Acceptance Body Handbook

Mr. Mahbod led the discussion regarding the Report Acceptance Body Handbook (RAB). RAB member qualifications were discussed. Mr. Mahbod noted there were six RAB meetings in 2020. Historically, meetings are held in person. However, due to COVID-19, meetings were held by Zoom after March 2020. He noted some reviews had been delayed.

OTHER

Ms. Rogers discussed the committee's charge to review state and national peer review. She reviewed the committee's responsibilities and discussed the continued allowance of remote system reviews per Peer Review Standards Interpretation 8-1.

RECAP OF PROC ACTIVITIES 2020

COVID-19 and the impact on Peer Review

Mr. Mahbod reviewed and shared PROC activities for 2020. He noted the AICPA Peer Review Board had granted automatic 6-month extensions for peer reviewers with original due dates between January 1, 2020, and September 30, 2020, due to the COVID-19 impact.

Mr. Mahbod discussed the 6-month extensions for peer reviewers and noted there had been no additional extensions.

Challenges or opportunities for PROC

Mr. Mahbod noted the PROC had adapted with the challenges brought on by COVID-19.
