**Mary Broz-Vaughan** shared an overview of the Department of Professional and Occupational Regulation with the group. She opened the floor for questions.

**Mr. Olson** reviewed the legislation (HB 516) that created the CNG Vehicle Mechanics Certification Program and led a discussion with the group on its content.

Review of HB 516

**Mr. Olson** gave a presentation describing the duties and responsibilities of the members of the workgroup and the planned advisory board, including FOIA requirements. He entertained questions and discussion from the Workgroup members.

Purpose of the Workgroup

**Mr. Olson** gave an introductory presentation of the regulatory process. This included an update on where the initial regulations for the CNG Vehicle Mechanic Certification program currently are and an estimated time table moving forward. Mr. Olson let the group know that a NOIRA would be posted on Town Hall June 16 and that there would be a 30 day public comment period. Any public comment received will be compiled and presented to the work group at the next meeting. After the Notice of intended regulatory action is over we have 180 days to complete our next step. Mark Courtney elaborated on the town hall information to the work group members.

The workgroup discussed the current Oklahoma licensing program for CNG mechanics as well as programs in Texas, Utah, and Colorado. This included a discussion regarding fuel tanks and the federal certification program for tank inspectors required by the Department of Labor and Industry.

Mr. Prack agreed to email statistics regarding the installation of conversion kits and fuel related accidents.

After reviewing the other programs and discussing other certification programs currently in place the group agreed that only one level of certification was required and that there should be a "grandfather" period in place during the initial period that the new regulations are in place.

Other recommendations were made to staff including education and training, experience, and substantially equivalent examinations. These recommendations will be included in the first draft of the regulations that will be presented to the workgroup at the next meeting.

The next meeting of the Workgroup will be held on Monday, July 14, 2014.
