The Board for Contractors seeks to amend its Individual eligibility requirements by amending the required years of experience and/or vocational training to obtain approval to sit for an examination and enter the profession. These amendments would affect Journeyman and Master electrical, plumbing, heating ventilation and cooling, gas fitter, liquefied petroleum gas fitter, and natural gas fitter tradesman.

On August 2, 2022, the Board approved a Notice of Intended Regulatory Action to amend the eligibility requirements for tradesman applicants seeking to obtain approval to sit for the Journeyman or Master electrical, plumbing, heating ventilation and cooling, gas fitter, liquefied petroleum gas fitter, and natural gas fitter specialties.

The Board is conducting a review of its Regulations in accordance with Governor Youngkin's Executive Directive 1.

During the review of their regulations in accordance to the provisions of Executive Directive 1, the Board identified their eligibility requirements as potentially burdensome to individuals entering the profession. The Board identified several areas to review and amend to lower the required years of experience while ensuring minimum competency and protection of the health, safety, and welfare of the public as its primary goal.

18 VAC 50-30-40 of the regulations provides detail on how individuals qualify to sit for the journeyman and master trade examinations. This would be amended to lower the years of experience required and provide additional options of experience and vocational training.

18 VAC 50-30-50 B1 of the regulations would be amended to include all individuals who successfully complete an electrical, plumbing, or HVA apprenticeship program through the U.S. Department of Labor or the Virginia Department of Labor and Industry.
