Regulations of the Board of Physical Therapy are promulgated under the general authority of Chapter 24 of Title 54.1 of the Code of Virginia. Virginia Code § 54.1-2400(6) specifically states that the general powers and duties of health regulatory boards shall be "[t]o promulgate regulations in accordance with the Administrative Process Act (§ 2.2-4000 et seq.) that are reasonable and necessary to administer effectively the regulatory system."

The Board has, however, identified areas or topics in these three regulations which may be reduced without impacting the health, safety, or welfare of citizens.

## Substance

In 18VAC112-20-27, the Board intends to remove outdated fee reductions. In 18VAC112-20-131, the Board intends to remove the specific lists of continuing education providers and move the list of Board-approved providers to a guidance document. Finally, the Board intends to review the advertising requirements of 18VAC112-20-200 with the intent of making that regulation less burdensome.
