This regulatory change changes the striped bass slot limit in Kerr Reservoir during the cool water period to protect larger fish as a part of the management of that fishery; expands the walleye limit in a portion of the New River, makes certain technical changes clarifying tributaries of the Dan and Staunton Rivers and clarifying that the Roanoke and Staunton Rivers are the same system, and adds limits on gar and bowfin harvest during certain time periods. All of these amendments are found in 4 VAC 15-320-25.

The change also creates a more specific and predictable process for the Department's issuance of fish stocking authorizations in 4 VAC 15-320-60. This includes a timeline for action on an application by the Department, specific conditions required for denial, and authorizations for necessary modifications to an approved stocking authorization.

The impetus for these regulatory changes is the Board's biennial periodic review of its aquatics/freshwater fisheries and boating regulations. Internal staff review, fisheries management goals, and consideration of subsequent public comment through the Board's regulatory development process found these changes advisable.
