The Department of Law (the "Department") is adopting its initial Public Participation Guideline ("PPG") regulations because it now is responsible for promulgating regulations for the former Virginia Human Rights Council after the operations of that agency was transferred to the Department's Division of Human Rights pursuant to the General Assembly's government reorganization legislation (2012 Acts, cc. 803, 835), effective July 1, 2012. The Division of Human Rights ("DHR") is authorized to promulgate regulations regarding the performance of its statutory duties. In addition, the Department is authorized to promulgate regulations regarding the issuance of a Civil Investigative Demand ("CID") under the Virginia Antitrust Act. The Department's regulations may be subject to periodic regulatory review, thus necessitating the Department's need to adopt its initial PPG regulations, which are based upon the model PPG regulations issued by the Virginia Department of Planning and Budget.

On February 11, 2015, the Department of Law submitted its initial Public Participation Guideline regulations to the Virginia Registrar for fast-track promulgation.
