The Certification Requirements for Mineral Miners, 4 VAC 25-35 are designed to provide a pool of qualified and certified mining employees and to ensure that miners are knowledgeable of the practices and processes of mining minerals in a safe and productive manner.

The Certification Requirements for Mineral Miners address application and examination requirements, reciprocity between states, renewals, first aid, and the individual certification requirements that are designated for positions with responsibilities underground and at surface mines as foremen, blasters, electricians, inspectors, and for general mineral miners. The final regulation is amended to include a provision that general mineral miners with applicable experience will be able to help complete pre-shift inspections at cement plants under supervision of a surface foreman.

The regulation also includes administrative changes that will allow different forms of payment for certification. These changes also include the requirement that applicants, except those already holding a journeyman electrician's card, take a written examination for certification as electrician, regardless of experience. The Board of Examiners certificates, prior to 1994 were to be valid until replacement with Board of Mineral Mine Examiners certificates. New certificates were to be issued with expiration dates between 1996-99 with no Board of Examiners certificate valid after July 1, 1999. These transition provisions are no longer needed and are being deleted. Lastly, surface blasters will be required to possess a valid record of three hours of first aid training from an organization using nationally recognized standards or training that meets federal 30 CFR Part 48 requirements. Prior to being changed, the certificate holder was only required to possess a valid MSHA 5000-23 first aid form.

On December 11, 2003, the Board of Mineral Mine Examiners adopted these final regulations entitled Certification Requirements for Mineral Miners, 4 VAC 25-35.

The Certification Requirements for Mineral Miners are promulgated at the discretion of Board of Mineral Mining Examiners and are not federally mandated. However, the federal MSHA accepts state certificates in lieu of establishing federal certifications.

The Board of Mineral Mining Examiners derives its authority to promulgate this regulation from the Code of Virginia, Section 45.1-161.292:19. Section 45.1-161.292:19. A specifies 8 certifications that must be issued by the Board. Section 45.1-161.292:12.B provides the Board the authority to require certification for additional tasks by regulation.

Section 45.1-161.292:19.C gives the Board of Mineral Mining Examiners the authority to promulgate regulations necessary or incidental to the performance of duties or execution of powers conferred under this title, which regulations shall be promulgated in accordance with the provisions of Article 2 of the Administrative Process Act.

The Office of the Attorney General has certified that the Department of Mines, Minerals, and Energy and the Board of Mineral Mining Examiners has the statutory authority to promulgate this regulation.

Purpose

The Certification Requirements for Mineral Miners, 4 VAC 25-35 were amended as a result of periodic review. During this review, the Board of Mineral Mining Examiners, with input from industry representatives as well as the Department of Mines, Minerals, and Energy, found minor edits were needed to bring the regulation up to date with the Code of Virginia.

Changes made to the regulation include administrative changes that remove a notary requirement and will allow different forms of payment for certification fees. Another change was to require that applicants, except those already holding a journeyman electrician's card, take a written examination for certification as electrician, regardless of experience.

The transition provision for Board of Examiners certificates to be replaced with Board of Mineral Mine Examiners certificates is being removed, it is no longer required. Lastly, surface blasters will be required to possess a valid record of three hours of first aid training from an organization using nationally recognized standards or training that meets federal 30 CFR Part 48 requirements. Presently, the certificate holder is only required to possess a valid MSHA 5000-23 first aid form.

The minimum certification requirements section was amended in the final regulation to accommodate mines that have cement plants onsite. The new section will offer to cement plant foremen, the flexibility to delegate plant area inspections to general mineral miners that are knowledgeable of cement plant operations.

The goals of the regulation are to ensure through proper examination and certification of persons working on mineral mines, the safest environment for workers employed at mineral mines without restricting productivity or efficiency. The regulation is necessary in that it establishes procedures and standards of certification for miners and workers working in areas of specific responsibilities at mineral mines.

Substance

4VAC 25-35-10 D. – The section is being amended to allow alternative forms of payment for certification fees for replacement of lost or destroyed certificates. Alternate forms of payment are already allowed for all other certification fees.

4VAC 25-35-20 A. – The section is being amended by deleting the language in the first sentence "... or those applicants with comparable work experience acceptable to Division of Mineral Mining under 4VAC 25-35-100 A". Experience alone is no longer recognized in lieu of an exam for those wishing to be certified electricians.

4VAC 25-35-30 – The section is being amended to reference a revised section of the Code of Virginia. It should read Code of Virginia section 45.1-161.292:24 rather than section 45.1-161.51.

4VAC 25-35-40 A. – This section is being amended to remove transition provisions for old certificates issued by the Board of Examiners. There are now no old certificates in effect.

4 VAC 25-75 – A new section is being added to allow cement plant inspections to be conducted by general mineral miners with the appropriate experience. Inspections would be conducted under the supervision of the surface foreman.

4VAC 25-35-80 B. – This section is being amended for clarity and to be consistent with continuing education requirements and federal requirements for first aid. Surface blasters will be required to have first aid training that meets nationally recognized standards.

4VAC 25-35-100 B. – The section is being amended for clarity and to be consistent with federal requirements. The section is also being amended to reference 30 CFR Part 46 as well as Part 48.

4VAC 25-35-110 – The section is being amended to reference a revised section of the Code of Virginia. It should read Code of Virginia section 45.1-161.292:11 rather than section 45.1-161.19 and section 45.1-161.292:12 rather than 45.1-161.20.

4VAC 25-35-120 A. - The section is being amended to reference a revised section of the Code of Virginia and work commencing date. It should read Code of Virginia section 45.1-161.292:28 rather than section 45.1-161.55. The section is also being amended to reference 30 CFR Part 46.

4VAC 25-35-120 C. - The section is being amended to reference a revised section of the Code of Virginia. It should read Code of Virginia section 45.1-161.292:28 B rather than section 45.1-161.55 B.

4VAC 25-35-120 G. – The section is being amended to be consistent with the Code of Virginia, section 45.1-161.292:28. The section should reflect a January 1,1997 starting date for General Mineral Miner certification.

As amended, this final regulation presents no new advantages or disadvantages to the public or the Commonwealth. The final regulation updates administrative requirements and makes the regulation consistent with the Code of Virginia. A substantive provision was added as a new section of the regulation, 4 VAC 25-75, that adds flexibility for cement plant operators to conduct plant safety inspections. There are no additional provisions added or made that are of consequence to the community, government officials, or the public.

Impact on family

Please assess the impact of the proposed regulatory action on the institution of the family and family stability.

The regulation is essential to protect workers at mineral mine sites by preventing health problems, accidents and fatalities in work that is inherently dangerous. Improper conditions and actions are a significant cause of injuries and fatalities.

The regulation sets forth requirements for the certification of individuals who work at mineral mine sites. A knowledgeable worker, a safe work environment and work practices reduce accidents that may result in reduced family income and increased family stress. Reducing accidents decreases these factors and has positive family impact. Ensuring that workers and operators know how to perform their jobs safely and efficiently has a generally positive effect in areas around mineral mines through protection of the public health, safety and welfare. The regulation has a positive effect on family formation, stability, and autonomy.
