Currently, 22 VAC40-470 notes, in part, that public assistance programs is defined at Virginia Code § 63.1-87. The purpose of the regulatory action is to amend the regulation to recognize that former § 63.1-87 is now § 63.2-100 due to the re-codification of this title.

The State Board of Social Services approved on December 13, 2007, the final exempt action to amend the Exemptions Applicable to Public Assistance Programs, 22VAC40-470-10.

Accordingly, restitution payments made to Holocaust survivors on or after August 1, 1994, will continue to be disregarded in eligibility determinations for public assistance programs as defined in § 63.2-100 of the Code of Virginia.
