This regulatory action incorporates adult services language and guidance from 22VAC40-800, Family Based Social Services, into a new regulation 22VAC40-775, Adult Services Standards. Family Based Social Services is being repealed as part of another regulatory action.

In addition to incorporating content from Family Based Social Services, the regulatory action adds language that more fully articulates the principles and actions associated with the provision of services to elderly individuals and adults with an impairment.

Sections 63.2-217, 63.2-1600, and 63.2-1602 of the Code of Virginia provide the authority for this regulatory action. Section 63.2-217 of the Code of Virginia provides the general authority for the State Board of Social Services to promulgate regulations to operate social service programs. Section 63.2-1600 describes the provision of home-based services. Section 63.2-1602 describes LDSS' participation in activities such as conducting nursing facility and home and community-based waivers pre-admission screenings and assisted living facility assessments.

Purpose

The new regulation describes the provision of services to elderly individuals and adults with an impairment. Services provided by LDSS AS workers promote the safety of elderly individuals and adults with an impairment and help prevent adult abuse, neglect and exploitation from occurring or recurring. Many of the services outlined in the regulation also strengthen adults' family and social support systems.

The regulation addresses services that help adults maintain self-sufficiency and support their wishes to live in community-based settings for as long as possible. The regulation outlines the principles and philosophy of adult services and underscores the importance of an adult's right to self-determination and independence.

This regulatory action updates and clarifies regulation content. Clarity in regulation content is essential to ensuring that the individual's health, safety and services needs are most appropriately met.

Substance

This new regulation includes regulatory language from 22VAC40-800. Content taken from 22VAC40-800 includes definitions of services; the principles inherent in the provision of Adult Services; a description of intake services; individuals to be served; and types of services that may be provided.

The regulatory action adds definitions of services; clarifies the philosophy of adult services; and provides additional guidance on intake services. Additionally, the new regulation more thoroughly details the population to be served, clarifies the descriptions of the type of services that may be offered to an adult, outlines the process of determining eligibility for services, and describes the responsibilities of the AS worker.

This action is necessary because the regulation that currently addresses Adult Services is being repealed by another regulatory action. Small businesses are not impacted by this regulation.
