22VAC40-780, Elimination of Financial Eligibility for Direct Social Services, provides authority for the provision of direct services to clients and clarifies that some services are provided without regard to income. This regulatory action makes three technical changes to update the terminology and to be compliant with statutory changes over the past several years.

In section 40, the term "Aid to Dependent Children" is changed to "Temporary Assistance for Needy Families." In section 60, the term "local social services agencies" is changed to "local departments of social services." Also in section 60, reference to the "Employment Services Program" is changed to lower-case "employment services programs." Code changes related to employment services programs make the current regulation's reference to "the Employment Services Program" inaccurate.

The State Board of Social Services took final action on 22VAC40-780 on June 15, 2011.
