These amendments were made to update the regulations relating to Motor Carrier Safety as a result of the 2019 Agency review of the applicable Federal Motor Carrier regulations. Technical and grammatical changes were made to ensure the Virginia and Federal Motor Carrier regulations are consistent. In particular the following actions were taken:

19 VAC 30-20-20 corrected a typographical error, the improper capitalization of the word "powers".

- 19 VAC 30-20-30 was amended to reflect that the regulations apply to both motor carriers and their drivers.
- 19 VAC 30-20-40 was amended to clarify that both Subpart E and F of 49 CFR 380 are incorporated into state law.

- 19 VAC 30-20-70 was corrected to capitalize the word "Federal".
- 19 VAC 30-20-80 was updated to reflect an effective date to ensure inclusion of any new updates to the Federal Motor Carrier Safety Regulations promulgated by the United States Department of Transportation, Federal Motor Carrier Safety Administration that are incorporated for compliance and enforcement purposes and to clarify that Subpart E and F of 49 CFR 380 are incorporated into state law.
- 19 VAC 30-2-110 made a capitalization correction.
- 19 VAC 30-20-130 made cross reference corrections and a grammatical correction.
- 19 VAC 30-20-140 made a capitalization correction.
- 19 VAC 30-20-150 was amended to clarify restrictions on certain Commercial Driving Licenses (CDL).
- 19 VAC 30-20-160 was amended to make a capitalization correction.
- 19 VAC 30-20-210 was amended to make a capitalization correction.
- 19 VAC 30-20-220 was amended to conform language used in Federal and State Regulations and to authorize submission of required forms electronically.
- 19 VAC 30-20-230 through 250 were amended to include intermodal equipment in addition to vehicles.
- 19 VAC 30-20-300 was amended to correct an internal cross reference to the CFR.

On January 31, 2020, the Virginia State Police adopted final regulations, in the nature of amendments, for 19 VAC 30-20, Motor Carrier Safety Regulations, as part of an internal Agency review of that regulation.
