This regulatory action will amend the Sales and Use Tax Dealer Discount regulation to reflect statutory changes in the Retail Sales and Use Tax and Vending Machine Tax Rates.

Legislation enacted by the 2004 General Assembly (2004 Acts of Assembly, Special Session I, Chapter 3) increased the sales tax rate from 4.5% to 5%. The regulation is being revised to reflect this legislative change.

As this action is necessary to conform to changes in Virginia statutory law where no agency discretion is involved, it qualifies for exemption from the Administrative Process Act and the Virginia Register Act under Code of Va. § 2.2-4006(A).
