The Virginia Marine Resources Commission (VMRC) proposes to amend Chapter 4VAC20-510-10 et seq., "Pertaining to Amberjack and Cobia", to streamline the cobia aquaculture permitting process.

### Mandate and Impetus

[Mandate] VMRC is authorized by § 28.2-201 of the Code of Virginia to promulgate regulations and guidelines necessary to carry out the provisions of Title 28.2.

[Impetus] All aquaculture requirements for acquiring broodstock, raising, and selling cobia are outlined in the cobia regulation. Removing this information from the regulation and creating a separate cobia aquaculture permit condition application will streamline the process of receiving a cobia aquaculture permit and better explain the requirements for raising and selling cobia. Creating this separate permit condition application will also streamline the administrative process of issuing a cobia aquaculture permit.
