Section 54.1-2349 of the *Code of Virginia* states in part that the Board shall have the power and duty to promulgate regulations to carry out the requirements of Chapter 23.3 of Title 54.1 of the *Code of Virginia*. In addition, 54.1-2349(A)(3) states that the Board shall establish criteria for the certification of employees of common interest community managers who have principal responsibility for management services provided to common interest communities or supervisory responsibility for employees who participate directly in the provision of management services. Section 54.1-201(E) states in part that regulatory boards shall promulgate regulations in accordance with the Administrative Process Act necessary to assure continued competence, to prevent deceptive or misleading practices by practitioners and to effectively administer the regulatory system administered by the regulatory board. The regulation is mandatory to implement Chapters 851 and 871 of the Acts of the 2008 General Assembly.

The regulation establishes the criteria for the licensure of common interest community managers to ensure the appropriate training and educational credentials for the provision of management services to common interest communities, as well as the standards of practice and conduct for common interest community managers and requirements for training programs. The regulation is clearly written and understandable. The regulation is currently undergoing review to develop certification standards for employees of common interest community managers and refine existing regulations to provide alternative qualification criteria for those seeking licensure.

Code of Virginia § 54.1-2349. A mandates the Common Interest Community Board to promulgate regulations. The continued need for the regulation is established in statute. Repeal of the regulation would remove the current public protections provided by the regulation.
