The regulation intended to protect the citizens of the Commonwealth is consistent with the stated objectives of applicable law and has little or no economic impact on small businesses. The requirement to have approved helmets is statutory in nature so the regulations, which adopt nationally accepted standards, do not impose any additional duty on small business. The regulation shall therefore be retained in its current form.
