Section 3.2-109 of the Code of Virginia (Code) establishes the Board of Agriculture and Consumer Services (Board) as a policy board with the authority to adopt regulations in accordance with the provisions of Title 3.2 of the Code.

Section 3.2-5302 of the Code authorizes the Board to adopt standards, grades, and size-weight classes including standards for the term "ungraded" for eggs marketed in the Commonwealth.

Alternatives to Regulation

The agency could attempt to enforce the standards for eggs such as grades and size and weight classes via the general statutes in the Egg and Hatchery Products Law (Va. Code § 3.2-5300 *et seq.*). However, those statutes lack the specific language necessary to enforce standards and the specific tolerances and quality factors noted in this regulation. The standards as identified in this regulation are reasonable and enable producers and retailers to market egg products that meet consumer expectations. The established standards for grade "AA", "A", "B" and "Ungraded" are reasonable and provide consistency, uniformity, and a specific set standards for egg quality. The requirement to properly label the eggs ensures that consumers are fully informed regarding the number of eggs purchased and where the eggs originated. This labeling requirement is not extensive but is in fact informative and necessary. The regulation also contains a general requirement to ensure that the eggs be produced, transported, and stored under sanitary conditions, which is not a difficult requirement and ensures consumer safety. Therefore, this regulation is the least burdensome alternative available for achieving the purpose of the regulation.

The regulation is necessary for the protection of public health because it ensures that consumers are provided egg products that meet specific quality standards. It is clearly written and easily understandable.

Decision

The agency recommends that the regulation be retained as is.

The regulation provides for eggs that are properly graded, in adherence to a specific standard. Additionally, the regulation requires that eggs be produced, distributed, and sold under conditions that are sanitary. It meets consumer expectations for a quality egg product while ensuring that those eggs are produced and held under sanitary conditions thus ensuring public health. The standards are easily achievable and are not burdensome to the industry.

The agency has determined there is a continued need for this regulation. The regulation provides for eggs that are properly graded, in adherence to a specific standard. Additionally, the regulation requires that eggs be produced, distributed, and sold under conditions that are sanitary. The agency has not received any complaints or comments regarding this regulation. The regulation is not complex. It is written in a straightforward manner and is easily understandable and enforceable by regulators. It is also easily understood by the regulated industry. The regulation does not overlap, duplicate, or conflict with federal or state law or regulation. The regulation was evaluated during the periodic review conducted in 2016. Since that time, there have not been significant changes in technology, economic conditions, or other factors that would necessitate amending this regulation. This regulation was promulgated with due concerns for industry and has minimal impact on small businesses. Compliance with the regulations will not require a significant effort by industry. The regulations are not complex, are easily understandable, and will present a minimal financial cost to the industry. Thus, although essential, the regulation will have minimal economic impact on businesses.
