This regulation is promulgated by the State Board of Local and Regional Jails, in accordance with §53.1-5 and §53.1-68 of the Code of Virginia. This regulation is necessary to interpret the law and ensure the

protection of the health, safety, and welfare of facility staff, defendants, and inmates in local correctional facilities and lock-ups.

Alternatives to Regulation

There are no known viable alternatives for achieving the purposes of establishing minimum standards for local correctional facilities and lock-ups as directed in §53.1-68 of the Code of Virginia. Authority has been vested with the Board in §53.1-5 of the Code of Virginia to adopt and promulgate regulations as may be necessary to carry out provisions set forth in the Code of Virginia.

6 VAC15-40, Minimum Standards for Jails and Lockups, meets the criteria set out in Executive Order 14 (as amended, July 16, 2018) in that it is necessary for the protection of the health, safety, and welfare of staff, defendants, and inmates within local correctional facilities and lock-ups. This regulation has proven effective in meeting this need and is deemed to be easily understandable. Due to changes in the Code of Virginia, amendments are necessary.

6 VAC15-40, Minimum Standards for Jails and Lockups is necessary for the protection of the health, safety, and welfare of staff, defendants, and inmates within local correctional facilities and lock-ups operating within the Commonwealth of Virginia. One comment was received concerning the regulation during the public comment period. The current regulation is not considered overly complex. The regulation does not overlap, duplicate, or conflict other federal or state law or regulation. In 2019, the regulation was amended to comply with a change in the Code of Virginia. Since then, other issues including changes to the Code of Virginia and the COVID-19 health crisis, have occurred which necessitate further review and changes to the regulation. There is no expected economic impact of the regulations on small businesses.
