The purpose of the Surface Water Management Area regulation is to prevent problems in the future by providing for the protection of beneficial uses in designated surface waters of the Commonwealth during periods of drought. The regulation details the process for designation of a management area. including the initiation of a surface water management area study, conditions under which designation shall take place, standards for determining the level of flow in need of protection, and criteria for issuing, modifying, revoking or denying a permit. The designation of a surface water management area will allow the state to have a management structure in place that could be invoked during periods of low flow.

The authority for this regulation is found in Title 62.1, Chapter 24, § 62.1-242 et seq. of the Code of Virginia. Specifically, § 62.1-246 authorizes the State Water Control Board (Board) to declare surface water management areas; § 62.1-247 authorizes the Board to issue surface water withdrawal permits; § 62.1-248 and 249 establish permit requirements; § 62.1-243, authorizes the Board to issue water withdrawal certificates and to establish certificate requirements.

There is no federal mandate for this regulation.

The Board received no comments in response to the Notice of Periodic Review of Regulations published in the Virginia Register on June 18, 2001.

The goals of the regulation are to: (1) protect the beneficial uses of the streams of the Commonwealth by identifying areas that may be impacted by low flows during drought periods and by designating those areas as Surface Water Management Areas, (2) provide a coordinated approach in managing and allocating the limited surface water resources of the Commonwealth during periods of low flow, and (3) ensure that water supply sources are protected and managed wisely.

This regulation has no direct impact on the institution of the family or family stability. It is clearly written and understandable for the entities directly affected.

The State Water Commission, a legislatively mandated panel charged with studying all aspects of water supply and allocation problems in the Commonwealth, has over the years, examined various approaches for resolving water supply and allocation problems, including imposition of an administrative statewide permitting system. Efforts to develop a comprehensive water policy have been largely unsuccessful due to the reluctance of the General Assembly to assert state control over the allocation of Virginia's water resources.

In 1989, the Water Commission recommended a compromise approach that would protect Virginia's streamflow levels while at the same time satisfy the needs of offstream and instream uses, by proposing the surface water management area legislation. This approach did not establish a statewide permit system but acknowledged both the differing values of the state's rivers and streams by designation of problem areas where, when flow levels fall below a specified level, water withdrawal will be managed according to a scheme that have been agreed upon by the withdrawers in the area.

The alternative to the limited management of only critical areas is a statewide permit system for water withdrawals that would regulate all withdrawers regardless of the impact of their withdrawals.
