This regulation is wholly supportive of the institution of the family and family stability by virtue of its intentional, directed review of all Department-related research protocols, to ensure the protection of the privacy and confidentiality of all information provided by human subjects involved in department-related research. A major feature required in IRB-approved research is "Informed Consent," that is, the right by each subject who participates in a research study to know the purposes of the research; any reasonable, foreseeable risks or discomforts to the subject; any benefits reasonably expected from the research; a statement of the confidentiality of records identifying the subject; and a statement that participation is voluntary and will involve no penalty or loss of benefits to which the subject is entitled and that the subject may withdraw his consent and discontinue participation at any time, without prejudice.
