- CALL TO ORDER:** A Special Conference Committee of the Board was called to order at 9:05 a.m.

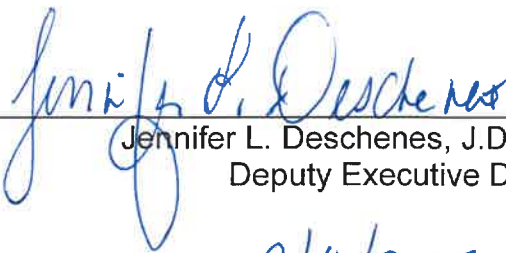
- CALL TO ORDER:** A Special Conference Committee of the Board was called to order at 10:26 a.m.
