Welcome and Introductions

Sanu Dieng, Committee Chairperson, called the meeting to order at 10:36 a.m. A quorum was present. Committee members introduced themselves. Elvira De la Cruz and Claudia Lopez-Muniz were present virtually. Pursuant to the Committee's electronic meeting policy, both explained they were attending virtually due to travel outside of the Commonwealth.

Approval of June 5, 2024 Meeting Minutes

Marva Dunn made a motion to approve the June 2024 minutes. Kate Hanger seconded the motion. The motion passed unanimously.

Virginia Sexual and Domestic Violence Program Professional Standards

Amber Stanwix and Andrea Sutton, the Professional Standards Team from the Virginia Department of Criminal Justice Services, provided members with an update regarding the Professional Standards

accreditation process. The presentation sparked a robust discussion about the Professional Standards and Professional Standards Committee.

State Agency Funding Updates

- Virginia Department of Criminal Justice Services
Kristina Vadas provided a summary of the victim assistance grant programs at DCJS. Presentation slides are attached.
- Virginia Department of Health
Maria Altonen was unable to attend; however, they provided an email update that VDH is working on an action plan for rape prevention funding. This plan is currently being reviewed by various stakeholders and will be released publicly in the near future.
- Virginia Department of Housing and Community Development
Kike Oliver informed the group that VDHCD has received an application for the Livable Home Tax Credit, as well as an application for the Virginia Housing Trust Fund Homeless Reduction Grant. In addition, she reported that the federal Continuum of Care competition is currently open.
- Virginia Department of Social Services
Nancy Fowler reported that there is currently an open grant solicitation for domestic violence services in certain named localities. In addition, VDSS has renewed applications for grants under the Primary Prevention Fund. Finally, VDSS has begun development of a domestic violence state plan.

Past Business

Kristi VanAudenhove reported that the Virginia Sexual and Domestic Violence Action Alliance has not yet reconvened the Language Access Workgroup. They plan to begin that work soon.

New Business

The group held a brief discussion regarding future plans for the Committee. One member suggested concentrating on the responsibilities assigned to the Committee under the *Code of Virginia*. Another member discussed concerns around workforce development, particularly for Sexual Assault Nurse Examiners (SANEs) and Forensic Nurse Examiners (FNEs).

Other Member Announcements

Kristen Howard informed the Committee that the Virginia State Crime Commission completed a draft report regarding the expungement of criminal records and urged the group to read it and report back to her with any comments.

Kristina Vadas introduced Kimberly Hill, who will be working on anti-human trafficking efforts within the Victims Services Team at DCJS. In addition, she reminded the group about the Building Bridges Conference that will be sponsored by DCJS in October.

Chairperson Dieng announced that Toni Zollicoffer will no longer be a member of the Committee, as she has accepted a different position within Fairfax County. In addition, she reported that she herself will no longer be serving on the Committee, as she has accepted a position with the Virginia Sexual and Domestic Violence Action Alliance. Finally, Kristina Vadas reminded the group that Tammy Sharpe has retired from her position and is therefore no longer serving on the Committee. This means that the Committee will now have three appointee vacancies.

Public Comment

Eileen Longenecker reported that the Supreme Court of Virginia will be hosting a domestic violence conference in November for judges and magistrates. The conference will be one and a half days long and cover a variety of topics.

Virginia Department of Criminal Justice Services

Victims of Crime Act (VOCA)

- Virginia's federal fiscal year 2024 VOCA award totals \$19,866,137, down from \$34,605,387 in FFY 2023.
- We anticipate a similar award in FFY 2025.
- Federal Crime Victims Fund balances remain concerningly low, but there are some efforts at the federal level to stabilize the fund.

DCJS VOCA-Supported Grants

- **Victims Services Grant Program (VSGP) Competitive**
 - SFY 2025 12-month awards began 7/1/24.
 - 32 awards totaling @ \$4,134,113 in VOCA and state general funds.
- **VSGP for Sexual and Domestic Violence Agencies (non-competitive)**
 - SFY 2025 12-month awards began 7/1/24.
 - 55 awards totaling \$15,800,255 in VOCA and state general funds.
 - Awards restored to slightly-higher than SFY 2023 levels (when combined with ARPA grant awards).

DCJS VOCA-Supported Grants

- **Victim Witness Grant Program (VWGP)**
 - SFY 2025 12-month awards began 7/1/24.
 - 114 awards totaling \$19,363,749 in VOCA and state funds (general and special funds).
 - Awards restored to @ SFY 2023 levels.

State General Funds

Reminder – In the final SFY 2025 state budget, additional **general funds** were appropriated for:

- Sexual and Domestic Violence Agencies
 - Increase of @ \$2 million to \$4,568,114
- Victim Witness Programs
 - Increase of @ \$1.3 million to \$5,988,807
- Support for competitive victim services projects
 - \$1,250,000

Violence Against Women Act (VAWA)

- Funds administered by the Office on Violence Against Women.
- Virginia's federal fiscal year 2024 SASP and STOP awards:
 - SASP = \$1,034,419
 - STOP = \$4,086,790

DCJS VAWA-Supported Grants

- **Sexual Assault Services Program (SASP)**
 - CY 2024: New grants began on 1/1/2024.
 - 31 awards totaling \$990,597 in federal SASP funds.
- **VSTOP**
 - CY 2024: New 24-month grants began on 1/1/2024.
 - 85 awards totaling \$9,195,215 in federal STOP funds for the 24-month period.

Other Funding Sources

- **ARPA VSGP Restoration Grants**
 - SFY 2025 12-month awards began 7/1/24.
 - 54 awards totaling \$3,365,679 in ARPA funds.
- **Virginia Sexual and Domestic Violence Victim Fund (VSDVVF)**
 - SFY 2025 12-month awards began 7/1/24.
 - 49 awards totaling \$2,258,803 in state general and special funds.

State Agency Funding Updates

- Virginia Department of Criminal Justice Services (DCJS)

Kristina Vadas from DCJS reported the following:

- Virginia's federal fiscal year (FFY) 2024 Victims of Crime Act (VOCA) award totals \$19,866,137, down from \$34,605,387 in FFY 2023. DCJS anticipates a similar award in FFY 2025.
- DCJS subgrantees are in middle of state fiscal year (SFY) awards for the following: Victims Services Grant Program for competitive applicants (VSGP); Victims Services Grant Program for Sexual and Domestic Violence Services non-competitive (VSGP-SDVS); Victim Witness Grant Program (VWGP); Virginia Sexual and Domestic Violence Victim Fund (VSDVVF); and American Rescue Plan Act for Sexual and Domestic Violence Services (ARPA-SDVS).
- Virginia Services, Training, Officers, Prosecution (VSTOP) awards are continuing into their second year in calendar year (CY) 2025.
- New CY 2025 Sexual Assault Services Program (SASP) grant awards will begin 1/1/25; 30 awards totaling \$970,586.

A committee member asked if and how state funds allocated in the SFY 2025 state budget helped lessen the impact of VOCA decreases. Kristina Vadas confirmed that additional state funds plus the final year of ARPA funds resulted in level awards in the VSGP-SDVS for SFY 2025.

A committee member asked about the amount of state special funds that are allocated in the state budget from the Virginia Crime Victim-Witness Fund (Fund) for the Victim Witness Grant Program, and how that amount differs from what is actually available to spend from that fund. Kristina Vadas confirmed that although the listed state budget amount is \$5,692,738 from the Fund, only approximately \$1.5 million is available to use from the Fund due to several years of low deposits, which resulted in low fund balances.

- Virginia Department of Health (VDH)

Maria Altonen from VDH reported the following:

- VDH's Rape Prevention Education (RPE) grant is coming to the end of its first year on 1/31/2025. This grant is on a five-year cycle. Year two begins on 2/1/2025.
- VDH is currently awaiting their Notice of Award from the Centers for Disease Control and Prevention (CDC) for approval for their year-two workplan and budget. Once they receive that approval, they will begin getting contracts in place for their subrecipients for year two.
- CDC released a new study on intimate partner violence during pregnancy. One in 20 women surveyed experienced intimate partner violence during pregnancy, according to a [new article](#) in CDC's *Morbidity and Mortality Weekly Report* (MMWR). CDC examined Pregnancy Risk Assessment Monitoring System (PRAMS) data from almost 50,000 respondents in nine U.S. jurisdictions from 2016-2022 to better understand experiences of intimate partner

violence during pregnancy and associations with prenatal care initiation, health conditions during pregnancy, substance use during pregnancy, and infant birth outcomes.

- Virginia Department of Housing and Community Development
Kike Oliver from VDHCD informed the committee that VDHCD had no report.
- Virginia Department of Social Services
Nancy Fowler from VDSS reported the following:
 - Several applications were received to establish new domestic violence services in the southside region; the grant review committee convened last week and negotiations are underway.
 - Some remaining ARPA funds are unobligated. Due to a lack of capacity at VDSS, we are engaging in conversations about alternative methods of distributing some additional funds that will need to be expended by 9/2025.
 - DVPS grants have one additional renewal available and will be effective July 2025.
 - UPOP grants are in their final months. A new RFA will be posted in the late winter, for new contracts beginning in July 2025.
 - SDV Prevention grants are in their second year, with two renewals remaining.
 - SDV ARPA grants will end June 2025.
 - Vaccine Testing ARPA grants will end September 2025.

Past Business

- Virginia Sexual and Domestic Violence Program Professional Standards
 - Kristina Vadas reported that she shared the committee's comments about the Professional Standards processes, that were shared at the September meeting, with the Professional Standards Committee Chairperson, Judy Castelee. DCJS is working with the Secretary of the Commonwealth's Office to fill vacant appointee positions. The Professional Standards Committee is discussing how they can encourage applications and generally enhance the program in 2025.
- Virginia State Crime Commission Language Access Study Request
 - No update.

New Business

- Revisions to *Policy on Participation of Virginia Advisory Committee on Sexual and Domestic Violence Members in Meetings by Electronic Means*
 - Kristina Vadas presented on proposed changes to this policy which will align it with current *Code of Virginia* language. Senator Favola made a motion to approve the revised policy. Marybeth Adkins seconded the motion. The motion passed unanimously.

- **Legislative Matters in Preparation for 2025 General Assembly Session**
 - Sanu Dieng-Cooper reported that the Action Alliance will continue pursuing the Put Victims First campaign that was started last year. The Action Alliance will also pursue a gun surrender bill concerning the relinquishment of firearms to third parties pursuant to a protective order. The Action Alliance will also support some bills carried by other organizations concerning reproductive rights.
 - Senator Favola reported that she will be seeking a state constitutional amendment concerning reproductive rights. Her hope is this will be on the ballot for voters in 2026.
 - On behalf of Delegate Shin, Kristina Hagen reported that Delegate Shin will be pursuing a bill to address a staffing crisis in forensic nursing. They are also working with forensic nursing representatives on bills that may address certification, training curricula, and protocols for tele-forensics.
 - Kylisha Boyd from the Office of the Attorney General (OAG) introduced Ebony McGill, who described changes to the Address Confidentiality Program (ACP) sought by the OAG in the upcoming session. These changes include the following: allowing law enforcement and others who work with sexual and domestic violence victims access to use the ACP for their personal addresses, and ensuring that applicants go through a victim assistance organization to apply.

Member Announcements

Elvira De la Cruz reported that recently, Latinos In Virginia Empowerment Center's (LIVE) social media pages received posts by some users expressing hateful and violent language towards the agency and the people they serve. These disturbing posts have resulted in significant distress and fear in the service community and among LIVE's staff. Staff feel they need to take extra steps to protect themselves, and they will be participating in active attack training offered by DCJS. They are also making some changes to their services to ensure staff safety. Committee members expressed support to Elvira, agency staff, and the people they serve.
