Enforcement Committee
Meeting Minutes
June 2, 2010

The Virginia Board of Accountancy's Enforcement Committee met on Wednesday, June 2, 2010, at 9960 Mayland Drive, Perimeter Center, 2nd Floor Commonwealth Conference Center, and Richmond, Virginia 23233

The Enforcement Committee opened the meeting with respect to Agenda Item A, the review of an open disciplinary case, which were discussed in closed session.
