SUBCOMMITTEE ACTIONS

The committee finished reviewing the list of recommendations that were provided, as well as the newly referred recommendations.

- #53P Feeding Mixing Equipment Tax Credit Program
 - DCR will provide recommendations related to all the tax credit suggestions and will discuss with partners and other stakeholders.
- #66P Remove Waste Management Practices from Priority List
 - Jay Yankey motioned to table, seconded by Martha Moore
 - Vote (17Y,0N)
- #67P Establish Regional Estimates of Nutrient Removal
 - Ricky Rash motioned to table, seconded by Greg Wichelns
 - Vote (16Y, 1N)
- #68P Establish a System to Annually Summarize District Performance on Cost-Efficiency
 - Joe Wood motioned to combine with 69P and amend, seconded by Steven Meeks.
 - Amendment: Explore other factors beyond pollutant loading rates in future funding distributions to the Districts.
 - Vote (15Y, 1N, 1A)
- #70P Standard Cost Estimates for Materials and Practice Payments
 - Greg Wichelns motioned to table, seconded by Steven Meeks
 - Vote (16Y, 1N)
- #71P WQ-12 Should be Eligible as a Carry-Over Practice
 - DCR recommendation: allow18 months for the implementation of eligible practices
 - Programmatic subcommittee recommends advancing
 - Vote (17Y, 0N)
- #72P Self-Certification Eligibility Language into Part I
 - Steven Meeks motioned to advance, seconded by Jay Yankey
 - Vote (17Y,0N)
- #1C Increase Cost-Share Rate and Incentives to Encourage Long Term Conversions
 - Greg Wichelns motioned to advance as amended
 - SL-1: Keep the cost-share rate at 75%
 - Raise the incentive payment (one-time payment) to \$100/ac for 10 year lifespan
 - Raise the incentive payment (one-time payment) to \$150/ac for 15year lifespan
 - Excludes recommendation of 20 and 30 year life span
 - FR-1: voted on by full TAC at 12/14/18 meeting
- #30C "Land Retirement to Open Space" Category to Require Higher Incentives
 - Recommendation withdrawn by District that submitted
- #13P Consider Removing All Practice and Participant Caps
 - The Programmatic Subcommittee held an extensive discussion on the removal of practice and participant caps
 - Combined with recommendations 14P and 15P
 - Carrie Swanson motioned that state will set generous practice caps for all BMPs, seconded by Charlie Newton
 - Voted (7Y, 9N), motion fails

- Martha Moore motioned to remove caps on certain practices as a pilot for a year (WP-4s, Sl-6) to approve or disapprove barrier issue, seconded by Keith Horsley
 - Motion withdrawn by Martha Moore
- Joe Wood motioned to require all Districts to set practice caps in secondary considerations; need variance procedure and guidance provided by DCR, seconded by Ricky Rash
 - Vote (3Y, 13N), motion fails
- The Programmatic Subcommittee recommends advancing the removal of all participant caps (include recommendations 13P, 14P, and 15P).
- The full Ag BMP TAC will be informed that the Programmatic Subcommittee could not agree on the removal of practice caps.
