Vice Chairman Amin called the meeting to order.

II. <u>Approval of Minutes</u> - On a motion by Mr. Holeman, seconded by Mr. Hoang, the December 12, 2017 Board of Directors Meeting minutes were unanimously approved. Voting aye: Vice Chairman Amin, Mr. Holeman, Mr. Hoang, Ms. Ganeriwala, Mr. Smith, Ms. Wiley, and Dr. Johnson. Voting no: None. (Mr. Joyce was not present for the vote.)

III. Economic Development Loan Fund (EDLF) Application

A. IDA of Pittsylvania County - \$2,800,000. Ms. Linda Gilbert, RLM for Southwest Virginia, presented the EDLF application to the Board. The IDA has applied for \$2.8 M in funding to support the expansion of Amthor International, Inc. A presentation was made to the Board by Mr. Matthew Rowe, Economic Development Director for Pittsylvania County. Mr. Rowe's presentation included information on the project's economic impact on Pittsylvania County, the facility to be constructed, and available workforce. Ms. Ashley Wolfe, Project Manager for Pittsylvania County, showed videos on the company's manufacturing process and Amthor's focus on customer service. Mr. Brian Amthor, Executive Vice President of Amthor International, Inc., spoke about the company's history and its connection to the community. Mr. Rowe, Mr. Amthor, and Ms. Green answered the Board's questions on the project. On a motion by Ms. Ganeriwala, seconded by Mr. Joyce, the Board of Directors unanimously approved the request by the IDA of Pittsylvania County for a \$2,800,000, 10-year loan

through the Economic Development Loan Fund to finance the construction of a manufacturing facility for lease by Amthor International, Inc. Voting aye: Vice Chairman Amin, Ms. Ganeriwala, Mr. Joyce, Mr. Holeman, Mr. Smith, Ms. Wiley, Dr. Johnson, and Mr. Hoang. Voting no: None.

- IV. <u>Board Review and Ratification of Loans Approved/Declined by Staff</u> On a motion by Ms. Ganeriwala, seconded by Mr. Joyce, the Board of Directors ratified the loan decisions made by staff for December 2017.
