II. Approval of Minutes

III. Recognition of Service

a) Messrs. Ronald Hobson, Ronnie Johnson, and Michael Joyce were thanked and given recognition for their years of service to VSBFA Board of Directors.

IV. Tax-Exempt Bond Project

a) N B Affordable Foundation, Inc - \$75,000,000 501c3 tax-exempt bond issuance was postponed to future meeting.

V. <u>Virginia Economic Development Partnership</u>

a) Nicole Riley with Virginia Economic Development Partnership presented the Innovative Framework of Economic Growth, no action required.

VI. <u>Economic Development Loan Fund</u>

a) IDA of Danville Economic Development Loan fund for \$1,360,504 for approval.

Linda Tackett presented with Corrie Bobe the Economic Development Loan Fund request. The financing will be used to refinance existing loans that the IDA has with the VSBFA and Virginia Community Capital.

Pursuant to presentations, Chairman Bew called for the motion to adopt the resolution. Mr. Richardson motioned to approve the resolution, seconded by Ms. Kastelberg, Motion carried. Voting aye: Mses. a) The Board reviewed three (3) credit support transactions and two (2) direct loans approved by management in aggregate of \$980,316 and one (1) direct loan declined by management in the amount of \$50,000.
