The Committee reviewed the allegations in the notice of informal with Mr. Simmes in that he may have violated the laws and/or regulations governing the practice of physical therapy.

Simmes, PTA. Additionally, Ms. Belmont moved that Board staff, Lisa Hahn, Kathy Truesdale, and Mykl Egan attend the closed meeting because their presence in the closed meeting is deemed necessary, and will aid the Board in its consideration in its deliberations. The motion was seconded and carried unanimously.

Ms. Belmont moved that the Special Conference Committee of the

Board of Physical Therapy certify that it heard, discussed or considered only public business matters lawfully exempted from open meeting requirements under the Virginia Freedom of Information Act and only such public business matters as were identified in the motion by which the closed meeting was convened. The motion was seconded and carried unanimously. **ACTION:** Mr. Howell moved to have Mr. Egan read the Findings of Fact and Conclusions of Law and the decision adopted by the Committee. Simmes is able to practice as a physical therapy assistant with reasonable skill and safety to the public, he may petition for the reinstatement of his license.
