	 18 VAC 112-20-10 Definition a) Possible deletion of "of the American Physical Therapy Association" from definition of term – "approved program."
	 b) Possible revision of terms – "direct supervision", "evaluation", "non-licensed personnel", "physical therapist", "physical therapist assistant", "trainee – (3) "unlicensed graduate trainee", and "traineeship."

- > 18 VAC 112-20-40 Education requirements.
 - a) Amending by adding requirement of the TSE (test of spoken English).
 - b) Granting the Board the authority to determine foreign credentialing body.
 - c) Requiring the Board to maintain an approved list of education facilities for students enrolled in an accredited program.
 - Amending regulations to suggest usage of Clerical Performance Instrument of APTA for reporting for foreign educated traineeship.
- 18 VAC 112-20-65 Requirements for the examination.
 - a) Amending section to allow Board to determine the passing score.
 - b) Amending section addressing test attempts and possible remediation and reducing time, or to delete limit.
 - c) Amending the requirements for applicants who have not taken exam within four years after graduation.

 - a) Amending requirements for the endorsement active licensure in another state; unencumbered license from another state; verification from all states; active clinical practice within three of the past five years.
