## NEW BUSINESS: Election of Officers

## **New State Travel Regulations**

Deborah Pearson, DHP presented the changes in the State Travel Regulations. The changes that will affect the Board with their travel vouchers are the changes in lodging rates and M&IE rates. Also, the members must have any travel pre-authorized and itemized. Ms. Young and staff prepare authorization and travel vouchers for the Board members.

#### **Annual Federation Conference**

Dr. Shoaf went to the Annual Federation Conference. She is a member of the Uniform Pathway Taskforce. She attended the presentation on Foreign-Trained PT's, Chris Larson and the Coursework Evaluation Tool Validation study presented the Road to Continued Competency. Dr. Shoaf also attended a discussion on NPTE item exposure and also session on Sexual Misconduct and Boundary Violations.

## **Disciplinary Legislation**

Gail Jaspen, Chief Deputy Director of DHP, discussed draft legislation introduced by Delegate Sears. The legislation proposes to change the standard of care from gross negligence to simple negligence, which will affect all boards. This legislation would increase penalty for hospitals failing to comply with notification requirements. If the hospital does not pay then they cannot renew their license. The increase in penalties will be from \$1,000 to \$5,000 per violation. Lastly, the legislation authorizes the Department of offer confidential consent agreements in disciplinary case decisions.

#### **OLD BUSINESS:**

2003 Virginia General Assembly Legislation.

Section 54-3408. Professional use by practitioners.

The draft legislation adds the following: Pursuant to an oral or written order of standing protocol issued by the prescriber within the course of his professional practice, such prescriber may authorize licensed physical therapists to possess and administer topical coricosteriods, topical lidocaine, and any other Schedule VI topical controlled substance as approved by the Board of Physical Therapy in regulation.

Ms. Garnett made a motion, which was seconded, that the Board approve the draft legislation, which carried by a vote of 4 yes and 1 abstention (Mr. Styron).

## **Legislative/Regulatory Committee**

Ms. Young said the Board needed to send out to the PPG list and adopt the NOIRA at the Board's January 2003 meeting.

## **Request for Interpretation**

Physical Therapists in Public Schools Regarding the Direct Access.

Mr. Roberts, Assistant Attorney General, explained the law regarding whether a physical therapist could conduct an evaluation on a student to be considered for an IEP and the answer was yes.
