# CONFIDENTIAL CONSENT ORDER:

Ms. Garnett provides a report from the Special Conference Committee providing examples of disciplinary cases for the confidential consent agreements.

The Board directed the SCC to ensure that individuals given CCAs complete their continuing competency units prior to entering into the agreement. Also, the Board asked staff to ensure all individuals under CCAs to be included in continuing competency audits.

The Board voted to defer the adoption of its CCA guidance document to the October board meeting.

# REQUEST FOR INTERPRETATION:

# **Therapeutic Riding Activities**

The Board reviewed a letter from a licensee requesting an interpretation of using a horse as a modality in providing physical therapy. The Board advised the Executive Director to respond by stating that the Board cannot provide legal interpretation to private entities and it cannot address reimbursement issues.

# Urodynamic Tests, Anorectal Manometry and EMG studies

The Board reviewed a request for interpretation regarding urodynamic tests, anorectal manometry and EMG tests as within the scope of practice of physical therapy. The Board viewed the tests as invasive procedures and is not allowed without a physician's referral. The Board viewed the procedures as tests, not treatments and not within the scope of practice of physical therapy. The Board directed the Executive Director to respond to the correspondence.

## **Dry Needling**

The Board requested the Executive Director to provide the standard response regarding the dry needling procedure. The response shall include a discussion of invasive procedures and citing the definition of the practice of physical therapy.

## **Department of Education**

Roscoe Roberts, Legal Counsel for the Board advised that DOE seek an interpretation from its counsel, Joan Murphy. The Board requested that the Executive Director assist DOE in revising a draft statement regarding IEPs and physical therapy in the public schools.

### **Kinesiotherapy**

The Board received an inquiry regarding the licensure of kinesiotherapists as physical therapists. The Board adamantly stated that kinesiotherapy requires a different curriculum and those graduates cannot be licensed as a physical therapist.

### Sharp Debridement performed by a LPTA

The Board reviewed the letter and requested the Executive Director to respond by citing the 54.1-3482 and the definition of practice of physical therapy. The Board also cited that it is the discretion and professional judgment of the licensed physical therapist as to whether the LPTA shall be allowed to perform sharp debridement.

#### LEGISLATIVE/REGULATORY MEETING

Lisa Shoaf, Chair of the Committee reviewed the proposed amendments to the regulations. Mr. Gieck expressed his opposition to the need for active practice hours and believes it to be an occupational standard, not a professional one.

The Board directed the Executive Director to send a thank you to Christine Lawson for her assistance in revising the regulations.

Mr. Howell made a motion, which was seconded, that the Board adopt the proposed regulations. The Board voted 5-1 to adopt the regulations with a no vote from Mr. Gieck.

Mr. Howell made a motion, which was seconded that the Board adopt its 2004 legislative proposal. The Board adopted the proposal.

#### **FCCPT**

The Board reviewed the new coursework evaluation tool utilized by the FCCPT for foreign-educated graduates.

#### **OLD BUSINESS**
