Communication

Mr. Quesenberry asked if there was any public comment.

Public Comment

Mr. Matt England, Master Esthetics Instructor at LAT, Inc./Institute of Advanced Medical Esthetics, addressed the Board on the topic of training hours for Estheticians, Master Estheticians, and Esthetician/Master Esthetician Apprentices. Mr. England made a recommendation that the Board consider increasing the training hours. The Board took Mr. England's remarks under consideration.

Ms. Martina Murray, Department of Veterans Services, addressed the Board on the topic of transferring school hours between vocational schools and private, non-accredited schools. The Board indicated that the policy and Guidance Document regarding transfer students is an item on the Agenda for today, and took Ms. Murray's remarks under advisement.

Mr. Thomas Sliger, a salon owner, addressed the Board on the topic of microblading curriculum in permanent cosmetic tattoo schools and the Board's guidance that microblading with the use of a blade is outside the scope of practice for Board licensure. The Board advised Mr. Sliger that a Guidance Document related, in part, to the subject of microblading is an item on the Agenda for today, and took Mr. Sliger's remarks under consideration.

Upon a motion by Ms. Dorey and seconded by Mr. Jones, the Board voted to reject the recommendation in the Summary of the Informal Fact-Finding Conference and deny Kymmori Latise Bell's license application.

The members voting 'yes' were Ms. Dorey, Mr. R. Jones, Ms. LaPierre, Ms. McCaffrey, Mr. Minor, Mr. Quesenberry, Ms. Quinn, Ms. Tsamouras, and Mr. Williams. The motion passed unanimously.

OLD BUSINESS

Examination

Mr. Melis reported to the Board on the transition to Professional Credential Services, Inc. (PCS) as exam vendor effective January 1, 2017. He informed the Board that theory examinations were being administered by Prometric at six Virginia sites, and that PCS has begun administering the practical exams.

Report on Vendor Transition

Mr. Melis also advised the Board that staff was tracking the development of the schools portal on the PCS website.

Mr. Melis reported that PCS held a meeting for schools on January 30, 2017 to provide an overview of the PCS examination process. Board staff, Board Chair, Lonnie Quesenberry, as well as Board Member Mr. Minor attended the meeting.

Mr. Kirschner reported that the revised Regulations went into effect on February 1, 2017. The Board was provided with copies of the new Barbers and Cosmetology Regulations and the new Esthetician Regulations.

Regulatory Report

Mr. Kirschner also informed the Board members that a meeting is scheduled for February 15, 2017, to which all licensed schools have been invited. The school representatives will be provided with an overview of the revised Regulations and a question and answer period will follow.

The Board was provided with a guidance document entitled, "License Required for Certain Procedures," for its review and approval. The guidance document (see Appendix A) consolidates previous interpretations of what license is required to perform eyelash extensions, microblading, and microneedling procedures.

The Board discussed amending the guidance document to specify the type of license required to perform eyelash extensions services.

Upon a motion by Mr. Williams and seconded by Ms. LaPierre, the Board voted to approve the guidance document.

The members voting 'yes' were Ms. Dorey, Mr. R. Jones, Ms. LaPierre, Ms. McCaffrey, Mr. Minor, Mr. Quesenberry, Ms. Quinn, Ms. Tsamouras, and Mr. Williams. The motion passed unanimously.

The Board reviewed the existing guidance document, dated May 12, 2014, regarding awarding of credits and/or hours to transfer students in Barber and Cosmetology schools. After discussion, the Board took no action on the guidance document.

Transfer Students Policy

The Board was asked to consider whether or not to require an Informal Fact Finding (IFF) Conference for applicants who are already licensed and have previously taken part in an IFF. The Board's consensus was that an IFF would not be required if there have been no new convictions since the previous IFF. New convictions received since the previous IFF would require a new IFF.

Informal Fact-Finding (IFF) Conferences for Individuals Already Licensed

Mr. Melis addressed the Board on the progress of the Esthetics Apprenticeship program with the Department of Labor and Industry. He indicated that work still needed to be done on the allocating of hours and defining work processes. Mr. Melis indicated that an ad-hoc committee would be established to formalize the details of the program. Ms. Tsamouras and Ms. LaPierre agreed to participate on this committee.

Esthetics Apprenticeship

Mr. Melis indicated that Board staff is continuing to work with the Department of Labor and Industry toward moving tattooing and body-piercing apprenticeships under the oversight of that Department.

Tattooing and Body-Piercing Apprenticeships

Mr. Melis and Mr. Kirschner provided training for Board members on completing the Conflict of Interest form required for each meeting.

In-Service Training

Mr. R. Jones initiated a discussion about the potential for a two-tiered barber

Guidance Document: License Required for Certain Procedures

Interpretation of what license is required to perform eyelash extensions, eyebrow embroidery/microblading, and microneedling under Code of Virginia §54.1-700 et. seq.

Applying eyelashes, as referenced in §54.1-700, refers to applying any natural or synthetic extension to an individual's natural eyelashes. This practice may be known as eye tabbing or eyelash extensions. These services require a cosmetology or esthetics license.

Strip, band, or bundle eyelashes, which adhere to the skin, are services that are ancillary to makeup, and exempted under §54.1-701.10.

Microblading, also called eyebrow embroidery, refers to the application of a semipermanent ink to the skin of the eyebrow. This practice, when performed with a needle or group of needles, requires a tattooing or permanent cosmetic tattooing license. Microblading performed with a scalpel is beyond the scope of licensure and should not be performed by a licensee of the Board.

Microneedling, also known as dermarolling, is the application of a series of needles on a roller device used to stimulate collagen production. This practice is beyond the scope of licensure and should not be performed by a licensee of the Board.
