On November 18 2020, the State Board of Elections certified the results of the November 3, 2020 General and Special Elections. After that certification, staff at the Department of Elections discovered errors in the total votes cast as certified by the City of Hopewell Electoral Board and the Prince William County Electoral Board. While the errors did change vote totals for the offices and questions listed in the attachments, they did not change the outcome of any of the contests or questions.

The State Board of Elections is being presented with revised abstracts of votes for the aforementioned contests and questions with vote totals changed to show revised totals based on the corrections from Hopewell City and Prince William County.

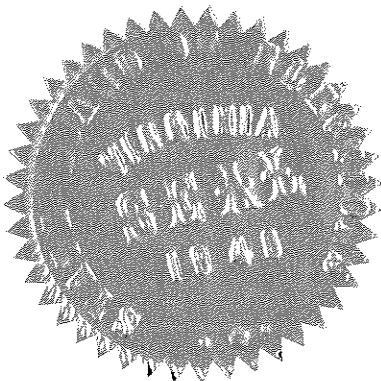
