MINUTES OF MEETING

The Virginia Board for Waterworks and Wastewater Works Operators and Onsite Sewage System Professionals met on July 26, 2018, at the offices of the Department of Professional and Occupational Regulation (DPOR), Perimeter Center, 9960 Mayland Drive, 2nd Floor, Board Room 3, Richmond, Virginia 23233.

Mr. Evans, Chair, called the meeting to order at 9:35 a.m.

Call to Order

Ms. Henshaw advised the Board of emergency evacuation Emergency procedures.

Evacuation Procedures

Mr. Fore moved to approve the agenda as presented. Mr. Greene seconded the motion which was unanimously approved by: Brockwell, Evans, Fore, Greene, Pruett, Roadcap, and Staples.

Approval of Agenda

Mr. Roadcap moved to approve the minutes of the April 19, 2018, Board meeting as presented. Mr. Fore seconded the motion which was unanimously approved by: Brockwell, Evans, Fore, Greene, Pruett, Roadcap, and Staples.

Approval of **Minutes**

There were no members of the public present to address the Board on matters other than the case files to be presented.

Public Comment Period

Mr. Fore recused himself from the meeting for discussion and deliberations on File Number 2018-01354.

Recusal of Board Member

In the matter of **File Number 2018-01354**, **Dwayne Edwin Huffman**, the Board members reviewed the Consent Order, which imposed Board costs of \$150.00. In addition, Mr. Huffman agrees to complete at least twenty hours of continuing professional education (CPE) limited to the content areas covered by the Board's examination and provide proof of completion of the CPE within three months of the effective date of the Consent Order. Ms. Pruett moved to accept the terms of the Consent Order as presented. Mr. Staples seconded the motion which was unanimously approved by: Brockwell, Evans, Fore, Greene, Pruett, Roadcap, and Staples.

Mr. Fore returned to the meeting.

Return of Board Member

In the matter of **File Number 2018-02552, Todd Bedford Hammer**, the Board members reviewed the record which consisted of the application file, transcript, and exhibits from the Informal Fact-Finding Conference, and the Presiding Officer's Summary and Recommendation. Mr. Staples moved to accept the recommendation of the Presiding Officer and approve Mr. Hammer's application for a Master Conventional Onsite Sewage System Operator license. Mr. Greene seconded the motion which was unanimously approved by: Brockwell, Evans, Fore, Greene, Pruett, Roadcap, and Staples.

File Number 2018-02552, Todd Bedford Hammer

In the matter of **File Number 2018-02601**, **James Michael Perry**, the Board members reviewed the record which consisted of the application file, transcript, and exhibits from the Informal Fact-Finding Conference, and the Presiding Officer's Summary and Recommendation. Mr. Greene moved to accept the recommendation of the Presiding Officer and approve Mr. Perry's application for a Class 4 Waterworks Operator license. Mr. Fore seconded the motion which was unanimously approved by: Brockwell, Evans, Fore, Greene, Pruett, Roadcap, and Staples.

File Number 2018-02601, James Michael Perry

In the matter of **File Number 2018-02984**, **Gerry Dale Roadcap**, the Board members reviewed the record which consisted of the application file, transcript, and exhibits from the Informal Fact-Finding Conference, and the Presiding Officer's Summary and Recommendation.

File Number 2018-02984, Gerry Dale Roadcap

Mr. Roadcap was present to address the Board. Mr. Roadcap stated that he is a licensee in the state of Colorado and has returned to Virginia where he was raised. Mr. Roadcap asked the Board to consider approving his application so that he may make a living in Virginia.

Mr. Greene moved to accept the recommendation of the Presiding Officer and approve Mr. Roadcap's application for a Provisional Class 3 Wastewater Works Operator license. Mr. Staples seconded the motion which was unanimously approved by: Brockwell, Evans, Fore, Greene, Pruett, Roadcap, and Staples.

Mr. Haughwout asked the Board to consider authorizing an exempt action to amend the Onsite Sewage System Professional (OSSP) Licensing Regulations as a result of the passage of House Bill 887, which expands the definition of maintenance to allow operators to perform some work previously only allowed by installers. After discussion and review of the proposed amendments to the regulations, Mr. Fore moved to authorize staff to file an exempt action to amend the regulations in order to align with current statute. Mr. Staples seconded the motion. After further discussion, the motion was unanimously approved by: Brockwell, Evans, Fore, Greene, Pruett, Roadcap, and Staples.

Consider Exempt Action to Amend OSSP Regulations (HB 887)

Ms. Lentz arrived at 9:48 a.m.

Arrival of Board Member

Mr. Saunders provided an update on the wastewater works operator CPE audit. The audit began on June 1, 2018, based on a random selection of 5% of current licensees.

WWW CPE Audit Report

Mr. Saunders provided an update on onsite sewage system professionals CPE audits. The audits began on June 5, 2018, based on a random selection of 5% of current licensees.

OSSP CPE Audit Report

Mr. Saunders provided the Board with examination statistics through July 10, 2018, for informational purposes.

Examination Statistics Report

Ms. Webster advised the Board that new questions recommended during a recent exam review are anticipated to be added to the OSSP exams by PSI within the next month.

Mr. Saunders presented the Board with a training course application from Aqua-Aerobic Systems, Inc. for a course titled *Innovative Treatment Technologies*. After discussion, Mr. Fore moved to accept the Education and Training Committee's recommendation and approve the course application, retroactive to April 26, 2018,

for a total of .36 training credits. Mr. Greene seconded the motion which was unanimously approved by: Brockwell, Evans, Fore, Greene, Lentz, Pruett, Roadcap, and Staples.

Jermaine Niblett and Lyell Jett, representatives of the Department of Corrections (DOC), were present to ask the Board to consider authorizing a waterworks operator apprenticeship program to mirror the current DOC wastewater works operator apprenticeship program. Mr. Niblett and Mr. Jett stated that allowing a waterworks operator apprenticeship program would improve employment opportunities and decrease even further the recidivism rate among inmates who participate in the program. Discussion was held on the following topics:

- following topics:the vetting process for candidates for the apprenticeship
- work and behavioral requirements of participants currently in the program;
- waterworks operator cross-training participants in the wastewater works operator apprenticeship program currently receive; and,
- the current number of program participants.

After discussion, Ms. Pruett moved to authorize DOC to offer a waterworks operator apprenticeship program contingent upon Board review of statistics on recidivism and current employment rates within the industry of participants in the program, and the number of participants who complete the program compared to those who are accepted into the program. Mr. Staples seconded the motion. After further discussion, Ms. Pruett withdrew the motion. The Board agreed by consensus that DOC will provide the requested statistics for review and further discussion at the October 25, 2018 Board meeting.

Lance Gregory from Virginia Department of Health (VDH) and Ms. Henshaw updated the Board on House Bill 888, which directs VDH to take steps to eliminate evaluation and design services for onsite sewage systems and private wells provided by the Department. The bill provides specific requirements and a timeline for such elimination.

Ms. Pruett asked the Board for guidance on a communication received from a licensee regarding a report prepared by VDH resulting from SB 1577. Ms. Pruett advised the Board that the licensee expressed his concern over the accuracy of statements contained in the report, and that he wanted the Board to request that VDH amend the report.

Update on HB 888 from 2018 General Assembly

Mr. Evans re-opened the public comment period and allowed Joel Pinnix, PE, AOSSO, to address the Board. Mr. Pinnix feels the VDH report states that the majority of onsite sewage system operators are incompetent and that the Board should be concerned about this finding as the regulators of OSSP licensees. Mr. Pinnix asked the Board to once again request that VDH adjust the language in the VDH report in order to put the findings in a proper context.

After discussion, the Board agreed by consensus that neither DPOR nor the Board has the authority to interpret VDH policies or regulations.

Ms. Henshaw advised that she has submitted a budget request to fund two Board members to attend the 2019 ABC conference. While this does not guarantee travel approval, the budget request was approved. The Board agreed by consensus to authorize Board members to attend the conference along with Board staff. Mr. Greene and Ms. Lentz volunteered to attend. Mr. Staples stated he was available as a back-up should Mr. Greene or Ms. Lentz be unable to attend.

Ms. Henshaw advised that ABC is currently seeking nominations for its Board of Directors and that Jason Spicer, Training Manager with the Department of Environmental Quality, has expressed interest in serving. Mr. Greene moved to nominate Jason Spicer for the ABC Board of Directors. Mr. Staples seconded the motion which was unanimously approved by: Brockwell, Evans, Fore, Greene, Lentz, Pruett, Roadcap, and Staples.

Mr. Staples relayed complaints received from his students regarding ABC exam facilities.
