Minute No. 1 - Review and Approval of Agenda: The Board approved the agenda.

**Minute No. 2 - Minutes:** The Board, on a motion by Ms. Moreno and seconded by Ms. Rovner, unanimously approved the minutes of the Board's meeting on March 16, 2017.

Minute No. 3 - High Priority Violations (HPV's) for the Second Quarter, 2017: The Board received a report from Ms. Kerri Nicholas, Division of Enforcement, on high priority violations for the second quarter of 2017.

Minute No. 4 - Division Directors Report: Mr. Michael Dowd, Air and Renewable Energy Division Director, briefed the Board on Executive Directive 11. The report covered Executive Order No. 57 (June 28, 2016); the Report and Final Recommendations to the Governor from the Executive Order No. 57 Workgroup (May 12, 2017); the Opinion of Attorney General Herring (May 12, 2017); Executive Directive 11 (May 16, 2017); and Virginia's rulemaking process including the State Air Pollution Control Law, Virginia Administrative Process Act (APA), and Executive Order No. 17. The Board requested a presentation in September on the status and discussions of the Regulatory Advisory Panel and advised staff that the Board may request additional briefings from staff prior to presentation of a proposal to the Board at the December 2017 meeting.
