## I. CALL TO ORDER

The meeting was called to order at 10:00 by Chairman Turpin.

#### II. INTRODUCTIONS

#### III. APPROVAL OF AGENDA

On MOTION duly made by Mr. Wilson and seconded by Ms. Brothers, the Board approved the agenda as presented. Motion carried.

# IV. APPROVAL OF NOVEMBER 12, 2008, MINUTES

The minutes of the November 12, 2008 Board meeting were presented for approval. On MOTION duly made by Mr. Wilson and seconded by Ms. Pacheco, the minutes of the November 12, 2008 Board meeting were approved as submitted. Motion carried.

## V. PUBLIC COMMENT PERIOD

Ms. Liane Rozzell, FAVY, distributed copies of her comments to the Board members. The two topics addressed were the budget crisis and family collaboration. Ms. Rozzell's written comments will be filed with the Board minutes and will be available upon request.

#### A. Secure Services Committee

#### Certifications

On MOTION duly made by Mr. Wilson and seconded by Ms. Pacheco to certify Fairfax Juvenile Detention Center and Fairfax Post-dispositional Program for three years. Motion carried.

On MOTION duly made by Mr. Wilson and seconded by Ms. Brothers to certify Lynchburg Regional Juvenile Detention Center and Post-disposition Program for three years. A status report is to be presented at the June 2009 meeting on compliance with mandatory standards and background checks. Motion carried.

On MOTION duly made by Mr. Wilson and seconded by Ms. Pacheco to certify Natural Bridge Juvenile Correctional Center for three years. Motion carried.

#### Issues

Highlands Juvenile Detention Center: Per Mr. Bailey, Highlands is currently in compliance with all of their areas with the exception of one and that is the issue wherein employees were hired before the facility received the CPS report. It was Highlands' interpretation that this was part of the variance, they now understand that they must have the report prior to hiring. Mark Lewis is working with Highlands' administrators to get things in order and the Department will continue to monitor their progress every six months.

Mr. Pullen distributed a copy of the Governor's 2008-10 budget reduction plan.

## VIII. Director's Comments

Mr. Green introduced Jim Nankervis. Mr. Nankervis is the new Chesterfield Court Service Unit director.

Mr. Green advised that he and Bruce Twyman met with the *Daily Press* Electorial Board on December 13 in Newport News. The Department will do an opt-ed piece for the paper in response to a negative article written by the *Daily Press*. Mr. Green stated that he feels that we have established a relationship with the paper and they will contact DJJ before printing articles. The *Daily Press* asked the Department to send them positive cases about the juveniles.

Mr. Green advised that the Expressions Arts and Crafts Show and Sale will be held February 2-6 at the General Assembly Building.

# IX. Board Comments

Ms. Pacheco thanked the Department for the wonderful work we do. She said she realizes difficult decisions that had to be made in light of the budget reduction but she applauds the Department for their efforts and hard work. Ms. Pacheco said she appreciates the strong commitment the Department has to its' employees and residents. Ms. Pacheco also commended Bruce on another good newsletter.

#### **Executive Closed Session:**

On MOTION duly made by Mr. Turpin and seconded by Mr. Wilson that the Board reconvene in Executive Closed Session, pursuant to Section 2.2-3711 (A), for discussion of personnel matters and for consultation with legal counsel and briefings by staff members, consultants or attorneys, pertaining to actual probable litigation, or other specific legal matters requiring the provision of legal advice by counsel, and for matters involving security otherwise exempt under the Freedom of Information Act.
