CALL TO ORDER

Chairman Francis called the meeting to order at 12:54 p.m.

DETERMINATION OF QUORUM

Chairman Francis determined there was a quorum present.

WELCOME AND INTRODUCTIONS

Chairman Francis welcomed everyone in attendance. He asked all attendees to introduce themselves.

APPROVAL OF JULY BOARD MINUTES

Chairman Francis presented the July 17, 2019 minutes for review and approval. The minutes excluded the Construction Projects presented by Bob Casey.

Upon a *Motion* by Chairman Francis and duly seconded, the members voted unanimously to *Approve* the July 17, 2019 Board meeting minutes as amended.

NOMINATING COMMITTEE

Chairman Francis appointed John F. Anderson, Jr. as Chairman of the Nominating Committee and appointed Reverend Kevin L. Sykes and Dr. Olivia Garland as committee members. Mr. Anderson was not in attendance for the July meeting and will present the committee recommendation at the November meeting

PUBLIC COMMENT PERIOD

None

PRESENTATIONS

Jim Bruce

Mr. Bruce discussed the passage of Chapter 725-Uncodified Acts by the General Assembly which requires the Board to address pregnant prisoners: use of restraint, noting that the patron intended for the default to be no restraint.

Additionally, The General Assembly passed Regulation Reform requirements under the same Chapter 725 Act. He noted that there are eight regulations promulgated by the Board that need template updates. He noted several Virginia Codes and was asked about the intention of the original regulations by Mr. Vassar. This issue will require further investigation and will be updated at a later date. Ms. Jennings was asked to investigate this issue further.

Chairman Francis offered the following in the form of a motion:

I *MOVE* to appoint Kemba Jennings as the Regulatory Coordinator for the Virginia State Board of Corrections.

Upon a *Motion* by Chairman Francis and duly seconded, the attending members voted unanimously to *Approve* the above recommendations.

LIAISON COMMITTEE UPDATE

Mr. Anderson provided an overview of the Funding and Budget Issues Report, Prison Population Report, the Jail Construction Update, Offender Management Services update as well as other business.

Mr. Anderson reported that Tim Trent served as chairman of the Liaison Committee meeting.

Mr. Anderson reported that Ms. deSocio reported that the Compensation Board and the VADOC had been approved for funding through the 2018 Legislature to create a data exchange between the DMAS and the CORIS/LIDs systems for state and local responsible offenders. Again, Ms. Tinsley is creating the system to share data from the jails. There was an extensive study to review requirements for the Inter-agency agreement. LIDs user agreements will be modified to increase access, secure the data and provide an index for coding. The biannual LIDs conference is currently in session. DMAS is working to provide training to approved jail staff and should be available in January when they are expected to go live.

State agencies are preparing budgets for the upcoming fiscal year 2021 through 2022 (FY21-22), which are required by later this month. The Compensation Board is reviewing anticipated needs for per diem funding such as staffing requirements based on capacities for expanded facilities such as Prince William Regional Jail. Per diem funding needs are based on approved forecasts. Ms. deSocio noted that the Compensation Board staff believe there is sufficient per diem funding for the current fiscal year.

Mr. Anderson reported that Ashley Morales and Sue Tinsley reported similar information as Ms. deSocio regarding the agreement and data sharing by DMAS (Virginia Department of Medical Assistance Services) and CORIS/LIDs to enable access of Medicaid Services for prison and jail offenders.

Mr. Anderson reported that Mr. Casey reported that Prince William/Manassas Regional Jail (204 bed expansion) is around 75% complete, with full completion expected in July 2020. Henry County is still trying to get costs down and are looking at 2022 if the project proceeds.

Mr. Anderson reported that Jim Parks reported the total for out-of-compliance inmates is 2,841 of which 2,566 are males and 275 are females. All female offenders will be classified out of State Farm with the goal being to consolidate females to one work center (Brunswick), which will become a CCAP (Detention and Diversion).

JAIL REVIEW COMMITTEE REPORT

Mr. Dean reported that the Jail Review Committee met on August 21 and again this morning and is now inviting representatives from facilities to provide context to the death reviews prior to deliberations and propsing of findings.

Mr. Dean offered the following motions:

Western Virginia Regional Jail

The Jail Review Committee investigated the following cases by reviewing institutional, medical, and mental health records and other relevant evidence of the circumstances surrounding each death. The Jail Review Committee *FINDS* that the evidence presented in these cases *DID* reveal acts or omissions by the facility or any employee or agent thereof that may have directly or indirectly contributed to the inmate's death. The Jail Review Committee further *FINDS* that the investigation *DID* reveal evidence indicating that the facility was out of compliance with the regulations promulgated by the Board. *NOW THEREFORE, I MOVE* that the following cases be recommended to the Full Board for action as a result of the following cases:

18-0016	Western Virginia Regional Jail	7/22/17

Pursuant to 6 VAC 15-20-100 (B)(3), your facility is *HEREBY* issued a *PROBATIONARY CERTIFICATION* for a period of *TWELVE MONTHS* from the date of this *Order*. Your facility has until its certification audit to come into compliance with the Board's Standards. If your facility does not meet the requirements for certification at the conclusion of this period, the Board will issue a *LETTER OF DECERTIFICATION*.

The facility shall provide written updates on measures taken to come into compliance with the Board's regulations at least quarterly during the probationary period.

Pursuant to Virginia Code §53.1-68, the Virginia Department of Corrections Compliance and Accreditation Unit is hereby directed to conduct quarterly random unannounced audits during the probationary certification period.

Upon a *Motion* by Mr. Dean and duly seconded, the attending members voted unanimously to *Approve* the above recommendations.

Mr. Francis noted that the Board has closed a case unintentionally and it needed to be reopened and the offered the following in the form of a motion:
