Colonel Chris Smith, Committee Vice Chairman called the meeting to order and welcomed all attendees.

Approval of Minutes

Colonel Smith called for a motion to approve the March 15, 2023 minutes.

Offender Management Services Update

Mr. Jim Parks shared an update from DOC. He reported that the out of compliance cases are as follows: Males -110; Females -74; total -184. He reported that there are a limited number of medical beds.

Other New Business

Colonel Smith shared on behalf of the facilities that they would like an update regarding standards that have been changed as well as being involved with the new process of Root Cause Analysis.

Mr. McCord went over the overall violations reviewed by the Board: Total – 147; Out of Compliance; No violations - 104. Breakdown of violations will be provided in added report.

Colonel Smith would like to add to Liaison agenda a discussion of standards with one jail violation along with the process of when a jail is out of compliance with a standard.

The Policy and Regulations Committee Chair, Dr. Cleopatra Booker advised that the Committee will be reviewing the Minimum Standards for Jails and Lockups. The Committee requested participation from the Virginia Association of Regional Jails (VARJ) and the Virginia Sheriff's Association (VSA). VARJ provided their list of individuals for the work groups; however, VSA has not yet responded with their list.
