Ms. Wampler opened the discussion of the draft Straw Man with consideration of Section 9 VAC 15-70-100 change of ownership, project modification and termination. Specific concerns include the requirement for notification of a change in ownership 30 days prior to the transfer date, and the need to provide DEQ with notice of liability agreements between the present and future owners. RAP members presented and discussed language for this section found in DEQ air permits which may be applicable.

The RAP also discussed Part III of the draft PBR, possible "de minimis" provisions for projects less than or equal to 5 MW of rated capacity. Several versions of the de minimis provisions were presented in the draft

Combustion PBR, including a DHR version and a DGIF version. Both were discussed, and the RAP membership agreed that it would be assist deliberations if the DHR and DGIF versions were merged into draft recommended language in the next iteration of the draft PBR. The RAP made several suggestions for consideration by the full body as noted in the annotated copy of the draft PBR attached to these meeting notes.
