## VPSTF Listening Session Minutes Friday, July 21, 2017. 10:00 AM – 2:00 PM DEQ Central Office, Richmond, Virginia Attendees: OSRR Staff, Environmental Consulting Community

OSRR hosted a listening session with the consulting community as part of preparing new Usual and Customary Rates (UCR). The goals of the listening session were to identify issues with the current UCRs, prioritize areas for possible improvement, and form a working group to continue discussion of UCRs and the Virginia Petroleum Storage Tank Fund (VPSTF).

OSRR staff and consulting community attendees are identified on Page 2.

OSRR staff began the session with a brief presentation of fund financial information, including recent annual revenue trends, claims processed and paid, and the most commonly claimed units.

During the morning session, the four discussion groups identified problem areas with current UCRs and reimbursement program practices. During the afternoon session, each group prioritized five items from their list to present to the larger group. Each of the four small groups explained their five priority items to the entire group. Each attendee was given five tokens to score their individual priorities from the total of twenty priorities presented to the group.

Priorities include:

- Overall rate increases based on inflation
- An increase in the general markup rate
- Same markup rates for C-code and X-code items
- A standardization of work scope across regions
- An increase in the rate for vacuum truck and a code for overtime rate
- Evaluation of T-codes
- An increase in the amount that may be authorized on the AAF without bidding.

OSRR concluded the session at 2:00 PM and invited attendees interested in joining the workgroup to be more involved in developing UCRs during the next revision.
