## Virginia Department of Energy Seeks Public Comment

As directed by the Virginia General Assembly, every four years Virginia Energy develops a comprehensive Virginia Energy Plan. Governor Glenn Youngkin's vision for the 2022 Plan is to develop a data-driven roadmap that considers all energy sources and is transparent with Virginians about the opportunities and costs each energy source presents while recognizing new information and learnings will continue to guide the process and decision making over time. The 2022 Energy Plan will provide energy policy recommendations that aim to balance the current and future needs of all Virginians, environmental goals, economic competitiveness, consumer choice and technology innovation. The plan will be built on a 4-R foundation of competitive rates to all energy consumers, reliable and responsible delivery of energy and rural economic development. The affiliations of stakeholders who submit comments on the Plan will be acknowledged in the Plan. All comments submitted to Virginia Energy related to the Virginia Energy Plan are subject to the Freedom of Information Act.

- 7. Are there objectives beyond competitive rates, rural economic development, and a reliable and responsible energy system that should be considered in developing the 2022 Virginia Energy Plan?
