She stated that the issue will come back for adoption of final regulations, and they should be in place by this summer. Ms. Yeatts suggested a periodic review of regulations. David Pawlowski moved to publish a Notice of Intended Regulatory Action for the periodic review of regulations to begin at the June Advisory Board meeting. The motion was seconded and carried.

#2. Legislative Update from the 2007 Session

Ms. Yeatts presented and explained new legislation affecting the Department of Health Professions, the Board of Medicine and the Advisory Board on Athletic Training.

#3. Efficacy of provisional licensure

Jon Almquist expressed concern regarding the proposed regulation 18 VAC 85-120-130, Supervisory Responsibilities. After discussion, the decision was made to go forward with the proposed regulation and determine the need to either amend further during periodic review or to delete the regulation for a provisional license all together.
