CLOSED SESSION: Upon a motion by Ms. Bowman, and duly seconded by Mr. Styron, the Committee voted to convene a closed meeting pursuant to §2.2-3711.A(27) of the Code of Virginia, for the purpose of deliberation to reach a decision in the matter of John Klemer, P.T. Additionally, he moved that Ms. Hahn, Ms. Petersen and Mr. Egan attend the closed meeting because their presence in the closed meeting was deemed necessary and would aid the Committee in its discussions. The Committee entered into closed session at 11:15 a.m.

RECONVENE: Having certified that the matters discussed in the preceding closed session met the requirements of §2.2-3712 of the Code, the Committee re-convened in open session at 12:36 p.m.

DECISION: Upon a motion by Ms. Bowman and duly seconded by Mr. Styron, the Committee moved to place Mr. Klemer on Probation for no less than 2 years. Mr. Klemer shall inform his current physical therapy employer and each future physical therapy employer that the Board has placed him on probation and shall provide each employer with a complete copy of his Order. Mr. Klemer must complete 16 hours of Continuing Education in addition to the required hours for renewal. Mr. Klemer is also subject to other Terms and Conditions as outlined in the final Board Order. The motion carried.


VOTE: The vote was unanimous.
