Mr. Melis and Mr. Kirschner provided, for the Board's review, an amended guidance document that addresses the awarding of credits and/or hours to transfer students. The original guidance document was approved by the Board at its February 10, 2014 meeting. The Board reviewed the proposed changes and recommended further amendments with regard to the schools' licensure by the appropriate state licensing entity and to the schools' accrediting agency.

The Board asked that staff discuss an option for a live model in all disciplines. Staff agreed to discuss the topic further with Ergometrics representatives.

New Business

Mr. Melis discussed with the Board the interpretation of statute as it relates to the scope of practice of cosmetologists and estheticians. The concluded interpretation was that a licensed cosmetologist may perform all of the practices of a licensed (basic) esthetician.
