## #2. Classroom hours combined with clinical care hours

Jeffrey Loveland addressed the advisory on a possible scheme that would combine classroom hours with clinical care hours to meet the active practice requirement for those individuals trying to reinstate. Ms. Yeatts informed that a regulation change would be required. Ms. Yeatts suggested that the Board members consider all possible alternatives to the current requirement for active practice hours and plan to make a recommendation at the Advisory Board meeting in June.

# **#3. Proposed Regulations for COTAs**

Elaine Yeatts explained the process for the replacement of Emergency Regulations by Final Regulations. Jean Hearst moved to recommend to the full Board in February that the Emergency Regulations be adopted as proposed Final Regulations. The motion was seconded and carried.

## #4. Supervision of COTAs

The Advisory Board discussed the supervision of occupational therapy assistants as written in Emergency Regulations. It was agreed that no changes were needed.

## **#5.** Report on the licensing of COTAs

Ola Powers reported that as of February 3, 2009, 122 occupational therapy assistants were licensed by the Board.

## #6. Grace period for licensure of COTAs

Jean Hearst asked about a grace period for the licensure of Occupational Therapy Assistants. Ms. Yeatts explained that there is no specific grace period or deadline for licensure in law or regulation. The Board agreed that all occupational therapy assistants working or wishing to work in the Commonwealth should apply as soon as possible.
